Background

- Federal Energy Regulatory Commission (FERC):
 - Responsible for issuing licenses for non-federal hydropower projects
- State Water Board:
 - Responsible for issuing water quality certifications for these hydropower projects
 - Certifications outline conditions to ensure compliance with Clean Water Act and other appropriate requirements of State law
 - Certification becomes part of FERC license

MOU Goals

- Improve coordination
- Provide input to licensing process as early as possible
- Improve timeliness of action (i.e., issuance of certification and associated license)
- Make efficient use of existing staff resources
- Retain independent authority

MOU Overview

- Focus on Pre-Application Activities
 - Pre-application activities occur prior to applicant's submittal of FERC license application and water quality certification application
 - Pre-application activities include:
 - Consultation;
 - Environmental scoping;
 - Study planning; and
 - Commenting on applicant's pre-license proposal
