**GENERAL INSTRUCTIONS FOR COMPLETING
LINEAR CONSTRUCTION TERMINATION NOTIFICATION (LCTN)
FOR TIER I SMALL LUPS**

Who May File

The discharger or duly authorized representative responsible for constructing Tier I Small LUPs may file a LCTN to notify the appropriate RWQCB office that construction activities associated with the Tier I small LUP or LUPs are complete and that the project meets one of the following criteria:

1. The construction project has been completed and the following conditions have been met: all elements of the Stormwater Pollution Prevention Plan have been completed; construction materials and equipment maintenance waste have been disposed of properly; the site is in compliance with all applicable local storm water management requirements including erosion/sediment control requirements; and all disturbed areas have been stabilized in accordance with Section A.8 of the Permit.
2. Discharge of construction storm water from the site is now subject to another NPDES general permit or an individual NPDES permit. The general permit or individual permit NPDES number and the date coverage began should be provided.
3. There is a new owner of the identified site. If ownership or operation of the facility has been transferred, then the previous owner must submit a Notice of Termination and the new owner must submit a Notice of Intent for coverage under the general permit. The date of transfer and information on the new owner should be provided. Note that the previous owner may be liable for discharge from the site until the new owner files a Notice of Intent for coverage under the general permit.

Where to File

The LCTN should be submitted to the Executive Officer of the Regional Water Board office responsible for the area in which the facility is located. If the Executive Officer, or his designated staff does not agree with the basis of termination the discharger or its duly authorized representative will be notified by the RWQCB office and the LCTN returned. The RWQCB office may also inspect your site prior to accepting the basis of termination.

LINE-BY-LINE INSTRUCTIONS

All necessary information must be provided on the form. Type or print in the appropriate areas only. Submit additional information, if necessary, on a separate sheet of paper.

WDID NO. (single and multiple project LCTNs must complete)

Enter the WDID number assigned to the NOI submitted to the SWRCB for the RWQCB office that has jurisdictional authority in the area where the Tier I small LUP or small LUPs was/were constructed.

SECTION I—DISCHARGER INFORMATION (single and multiple project LCTNs must complete)

Enter the Company's official or legal name (This should correspond with the name on the Notice of Intent submitted for the RWQCB Region), address of the owner, contact person, and contact person's title and telephone number.

SECTION II – TYPE OF LCTN (single and multiple project LCTNs must complete)

Select if this LCTN is for a single project or for multiple projects within a RWQCB office jurisdiction.

For single projects complete WDID, Sections I, II, III, IV, V and VI.

For Multiple Projects complete WDID, Sections 1, II and Section VI, Table 1 for Multiple Tier I Small LUPs.

SECTION III-AUTHORIZED REPRESENTATIVE (single project LCTN must complete)

Enter the name of the authorized representative, their address, contact name, and contact person's telephone number. An authorized representative is a contractor employed by the owner or operator of the small LUP and is the person responsible for oversight of the day to day operations of construction activities associated with small LUPs.

SECTION IV: PROJECT INFORMATION (single project LCTN must complete)

Enter the location (street address or description) of the construction site. This should be the same information provided on the LCAN.

If contaminated soil (Discharge Prohibition A.5, footnote 4 of the Order, BMP2-06) was encountered during the small LUPs check the box provided here and list the suspected contaminants in the space provided or in the area provided for explanations.

Provide a brief description of the project.

SECTION V--BASIS OF TERMINATION (single project LCTN must complete)

Check the category that best defines the basis of your termination request. Provide dates and other information requested. Provide an explanation as needed in the space provided or attach additional sheets if additional information is to be provided.

SECTION VI—CERTIFICATION (single project LCTN must complete)

a) This section must be completed by the discharger or its duly authorized representative and must be signed in accordance with Signatory Requirements specified in NPDES Order No. CAS 000005. If the box located here which states that the project was not in compliance with this Order and the sites SWPPP has been marked, please explain the noncompliance fully in the "Basis for Termination". You may refer to prior submittals to the RWQCB during the explanation.

b) This section must be completed by the discharger or its duly authorized representative and must be signed in accordance with Signatory Requirements specified in NPDES Order No. CAS 000005.

LINE-BY-LINE INSTRUCTIONS (CONTINUED)

Project Location and Description:

Enter the location (street address or description) of the construction site. This should be the same information provided on the LCAN. Provide a brief description of the project.

Authorized Representative:

Enter the name of the authorized representative, their address, contact name, and contact person's telephone number.

Basis for Termination Request:

Check the category that best defines the basis of your termination request (Columns 1,2, or 3). Descriptions of the categories are provided on the first page used for single project termination notification, match the number provided in the row on Table 1 with the category number provided for the single project listing. Provide dates and other information requested. Attach additional sheets if additional information is to be provided.

Contaminated Soil:

If contaminated soil (Discharge Prohibition A.5, footnote 4 of the Order, BMP2-06) was encountered during the small LUPs check the space provided here marked "yes" and list the suspected contaminants in the space provided or in the area provided for explanations. If not contaminated soil was encountered check the space provided here marked "no".

Certification:

a) This section must be completed by the discharger or its duly authorized representative and must be signed in accordance with Signatory Requirements specified in NPDES Order No. CAS 000005. If the space located here which states that the project was not in compliance with this Order and the sites SWPPP has been marked, please explain the noncompliance fully on a separate page. You may refer to prior submittals to the RWQCB during the explanation.
