RESOLUTION NO. 78-66

ADOPTION OF THE MONTEREY BAY AREA 208 PLAN

WHEREAS:

1. In May 1975, the Board designated the Association of Monterey Bay Area Governments (AMBAG) as the Areawide Waste Treatment Planning Agency for the Monterey Bay Area pursuant to Section 208 of PL 92-500;
2. In July 1975, the U. S. Environmental Protection Agency (EPA) awarded AMBAG a grant of \$829,000 to develop an areawide waste treatment management plan (208 plan);
3. In May 1976, the Board approved AMBAG's detailed workplan for the preparation of the 208 plan;
4. On July 12, 1978, the AMBAG Board of Directors adopted the 208 plan;
5. On August 28, 1978, the Board held a public hearing on the plan and has reviewed the testimony in addition to all comments on the plan received;
6. The 208 plan to be considered for adoption by the Board as fulfilling requirements of Section 208 of PL 92-500 consists only of those plan actions of the plan which pertain to or interface with water quality;
7. The plan conforms with the provisions of the approved workplan;
8. The plan conforms with all state and local legislation, regulations, or other requirements of plans regarding land use and protection of the environment;
9. The plan is consistent with the water quality management needs of the area;
10. The plan is in conformance with the provisions of Section 208 of PL 92-500 and federal planning regulations contained in Title 40 CFR, Parts 130 and 131, with the exception of required plan elements pertaining to population projections and the specific identification of management agencies; and
11. The Board has previously approved a Water Quality Control Plan for the Central Coast.

THEREFORE BE IT RESOLVED:


That the Board, acting for the Governor of the State of California:

1. Adopts the aforementioned plan (as defined under Item 6 of the above) in fulfillment of Section 208 of PL 92-500 with the following qualifications:

- A. The plan represents an initial planning effort and as such must be carefully reviewed and revised, if appropriate, as a part of the continuing planning process;
  - B. Before the Board can designate management agencies to implement the plan, AMBAG must provide, within sixty days, the following:
    - (1) A list of management agencies;
    - (2) A description of specific and scheduled actions to be taken by each management agency;
    - (3) A description of existing responsibilities of each management agency and a description of which actions in (2) are not currently being undertaken; and
    - (4) Evidence that each management agency is aware of the actions required by the plan and that the agency is capable and willing to assume responsibility for carrying out such actions.
  - C. As a part of the continuing planning process and within six-month's time, AMBAG must incorporate, as part of the plan, a single set of specific population projections in five-year increments over a twenty-year time period, in conformance with the State Board's Clean Water Grant Regulation 2133 C;
  - D. The twenty-year project list of municipal wastewater facilities, which is adopted as a part of the plan, will be updated by the Central Coast Regional Water Quality Control Board with the assistance of AMBAG, as part of the continuing planning process; and
  - E. Although the continuing planning process is an integral part of the plan, Board approval of continuing planning elements will be based on an acceptable workplan prepared in accordance with Planning Program Guidance Memorandum No. 11.
2. Approves the continued designation of AMBAG as the Areawide Waste Treatment Planning Agency pursuant with the following qualification:
    - A. The continuing planning process in the Monterey Bay Area, as it pertains to Section 208, must be in conformance with an approved workplan and consistent with the Board's Planning Program Guidance Memorandum No. 11.
  3. Authorizes the Executive Director to submit the 208 plan for the Monterey Bay Area to EPA for approval with the stipulation that the water quality management plan for the Monterey Bay Area is comprised of both the 208 plan as prepared by AMBAG and the relevant portion of the water quality control plan for the Central Coast Basin.
