## STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 93-94

### ADOPTION OF THE FFY 1994 STATE REVOLVING FUND (SRF) LOAN PROGRAM PRIORITY LIST AND AMENDMENT OF THE "POLICY FOR IMPLEMENTING THE STATE REVOLVING FUND FOR CONSTRUCTION OF WASTEWATER TREATMENT FACILITIES"

#### WHEREAS:

- 1. The availability of funds under the SRF Loan Program and the interest expressed for developing and implementing nonpoint source, water reclamation, storm drainage pollution, and estuary enhancement programs and projects support funding Priority Classes A through D in FFY 1994;
- 2. It is expected that the FFY 1994 appropriations bill will allow the States to fund major sewer system rehabilitation (Needs Category IIIB), new collection system (Needs Category IVA), and combined sewer overflow projects (Needs Category V) projects without limitation;
- 3. The State Water Board established a funding cap on projects in FFY 1993 and the need exists to continue the cap for FFY 1994 to assure a reasonable distribution of the available funds, and the Division has proposed a sliding scale for the FFY 1994 cap based on two possible levels of federal and State funding:
- 4. The Federal Clean Water Act allows the States to reserve four percent of their annual SRF allotment for loan administration;
- 5. A need exists to provide increased assurance that water reclamation projects can be funded in FFY 1994 to help promote meeting of statewide water reclamation goals as set by the Legislature; and
- 6. The Division of Clean Water Programs (Division) has developed the FFY 1994 SRF Loan Program Priority List based on Regional Board and public input consistent with the Federal Clean Water Act.

# THEREFORE BE IT RESOLVED THAT:

The State Water Board:

- 1. Approves the placement of Priority Classes A through D on the fundable portion of the FFY 1994 Priority List;
- 2. Approves funding in FFY 1994 for new collection system and combined sewer overflow projects and defers funding for major sewer rehabilitation projects for FFY 1994 and directs that major sewer rehabilitation projects be placed on the unscheduled portion of the list;
- Authorizes the Division of Clean Water Programs to set the funding cap at \$5 or \$10 million (the amount of funds that any one agency can receive from FFY 1994 funds) depending on the level of funding available in FFY 1994;

- 4. Approves the set-aside of four percent of the FFY 1994 Capitalization Grant amount for SRF Loan Program administration;
- 5. Approves the creation of a set-aside equal to 30 percent of the available FFY 1994 funds for water reclamation projects until April 1, 1994;
- 6. Approves amendment of "Policy for Implementing the State Revolving Fund for Construction of Wastewater Treatment Facilities" combining Priority Class E with Class C as shown in Exhibit C; and
- 7. Adopts the final FFY 1994 SRF Loan Program Priority List.
