

STATE WATER RESOURCES CONTROL BOARD
RESOLUTION NO. 96-052

RESOLUTION APPROVING THE REPEAL OF CERTAIN SECTIONS OF
TITLE 23 OF THE CALIFORNIA CODE OF REGULATIONS

WHEREAS:

1. The Governor has issued Executive Order W-127-95 asking each state agency to review its regulations affecting business and eliminate or modify as many as are suitable.
2. Staff has identified certain sections of the SWRCB's regulations that are no longer needed.
3. The input of the affected public has been sought and comments from the affected public have been received.
4. Notices of the proposed repeal of regulations were published by the Office of Administrative Law, notices were sent to persons on the SWRCB's mailing list, and notice of this hearing was provided to all who have expressed an interest in the repeal of regulations.
5. Public comments have been received and staff will prepare written responses for the record to each such comment.

THEREFORE BE IT RESOLVED THAT:
