# **SUBJECT**

CONSIDERATION OF A PROPOSED RESOLUTION FOR OPERATOR CERTIFICATION AND TRAINING ADVISORY COMMITTEE (ADVISORY COMMITTEE) APPOINTMENT

# **DISCUSSION**

The Water Code, Sections 13631 - 13633, requires that the State Water Resources Control Board (State Water Board) appoint a nine-member Advisory Committee to assist in carrying out its duties regarding wastewater treatment (WWTP) plant operator certification. The State Water Board has maintained an Advisory Committee since the WWTP operator certification regulations were adopted in 1972. The operator certification regulations require that Advisory Committee members be appointed for a four-year term. The terms of four Advisory Committee members expired on June 30, 2012.

The State Water Board has received four nominations, or re-nominations, from those statewide organizations listed in the Water Code Section 13632 and from State Water Board staff. These nominees are listed below. The nominees have indicated directly to Division of Financial Assistance staff that they are willing to serve on the Advisory Committee.

For the period beginning July 1, 2012, and ending June 30, 2016:
