#### **EXECUTIVE UST CLOSURE AUTHORITY**

RTD agrees with the proposed resolution granting authority to the Executive Director to close UST sites that meet or exceed the required criteria of the Low-Threat Closure Policy.

- 1) We recommend that this resolution also grant the Executive Director the authority to approve cleanup plans submitted by dischargers and rejected by local regulators that are designed to meet or exceed the criteria of the Low-Threat Closure Policy.
- 2) We recommend that for approving closure or cleanup plans, the Executive Director can only delegate this authority to staff who are Professional Engineers or Geologists in good standing.

## CONCLUSIONS AND RECOMMENDATIONS

The draft Delegation of Authority is a much needed improvement for helping to focus UST site closure.

We recommend some focused fine tuning of this draft Resolution to include the authority to review cleanup pland and to ensure that any delegation to staff by the Executive Director is limited to appropriately licensed and experienced professionals.
