DIVISION OF WATER QUALITY

Amendment to the Once-Through Cooling Policy: State Water Board staff transmitted the administrative record for the amendment to the Water Quality Control Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling (or Once-Through Cooling Policy) to the Office of Administrative Law on October 14, 2020. The amendment to the Once-Through Cooling Policy was adopted on September 1, 2020, and extended the compliance dates for Alamitos, Huntington Beach, Redondo Beach, and Ormond Beach generating stations to ensure grid reliability, and revised the compliance dates for Diablo Canyon Nuclear Power Plant.

PFAS Sampling for Military Owned Drinking Water Wells and Water Systems: The State Water Board's Division of Water Quality (DWQ) and Division of Drinking Water (DDW) are working closely with the Department of Defense (DoD) on identifying and sampling of appropriate municipal supply drinking water wells and drinking water systems that may be at risk to per- and polyfluoroalkyl substances (PFAS) contamination from historic military operations. In March 2020, the DoD began implementation of their Per – and Polyfluoroalkyl Substances Sampling of Department of Defense Drinking Water Systems Memorandum (PFAS DoD Memo). This memorandum identified requirements for PFAS drinking water sampling on military installations where the DoD is the drinking water purveyor. The memorandum also states that they will comply with state requirements and analyze samples by the newer U.S. EPA Method 537.1.

In addition, DWQ and DDW received confirmation in September 2020, from Maureen Sullivan with the Office of the Assistant Secretary of Defense, that the military will also include sampling raw water sources (supply wells) that serve the military's drinking water systems for PFAS. It is common practice for multiple water sources to be blended prior to serving the water. If PFAS is detected in the drinking water sample, the raw water data collected will help identify which raw water source is potentially contributing PFAS to the system. The DoD will be submitting drinking water and source water data results through DDW's EDT Library/Safe Drinking Water Information System likely in early 2021. Science Advisory Panel on CECs in Aquatic Ecosystems: The State Water Board and Ocean Protection Council are jointly funding the Southern California Coastal Water Research Project to reconvene the Science Advisory Panel on Constituents of Emerging Concern (CECs) in Aquatic Ecosystems (Panel) to update its recommendations for monitoring and management of CECs in marine, freshwater, and estuarine ecosystems. The Panel will update the risk prioritization framework developed in the 2012 report, Monitoring Strategies for Chemicals of Emerging Concern (CECs) in California's Aquatic Ecosystems

(https://www.waterboards.ca.gov/water_issues/programs/swamp/cec_aquatic/docs/cec_ecosystems_rpt.pdf) to address classes of chemicals, structurally related chemicals, and data-poor chemical classes. The Panel will also provide the State Water Board with guidance on which classes of CECs have the potential to adversely impact marine, estuarine and freshwater wildlife, ecosystems, and beneficial uses, and will recommend management actions for the Water Boards to take to address CECs in the aquatic environment.

The Panel began its deliberations with four two-hour public webinar meetings October 12-15, 2020. The Panel plans to deliberate through summer 2021 and will produce its final report in December 2021.

Water Quality Certification, Public Trust, Cannabis, Administrative, & Reporting Branch

Lower Klamath Project License Surrender: On October 22, 2020, State Water Board staff participated in a quarterly Interim Measures Implementation Committee (IMIC) meeting. The purpose of the IMIC is to collaborate with PacifiCorp on implementation of Interim Measures set forth in the November 30, 2016, Amended Klamath Hydroelectric Settlement Agreement (KHSA). During the meeting, PacifiCorp and IMIC participants

discussed the Federal Energy Regulatory Commission's (FERC) July 16, 2020 Order that partially transferred the license to the Klamath River Renewal Corporation and retained PacifiCorp as a co-licensee. PacifiCorp asserted that this does not conform to the structure of the KHSA. As background, on July 23, 2020, per the KHSA, PacifiCorp initiated a Meet and Confer with KHSA signatories and negotiations are ongoing related to FERC's July 2020 Order. The IMIC meeting also included updates on the following efforts: Biochar Pilot Filtration Project; Agricultural Water Budget and Nutrient Assessment; Upper Basin Watershed Action Plan; Phase 1 of the Phoslock Feasibility Study; operation of the Iron Gate Dam Intake Barrier Curtain; Tulelake Irrigation District Modernization Study; and Interim Measure 11 (interim water quality improvements) 2021 Study Plan.

Bucks Creek Hydroelectric Project: On October 22, 2020, the Executive Director issued a water quality certification (certification) for Pacific Gas and Electric Company (PG&E) and the City of Santa Clara's Bucks Creek Hydroelectric Project (Project). The City of Santa Clara issued a California Environmental Quality Act Supplement for the Project. As background, the Project is located approximately 17 miles from Quincy, California, in Plumas County. The Project diverts water from Bucks Creek, Grizzly Greek, and Milk Ranch Creek, which is discharges into the Upper North Fork Feather River. Lake Fordyce Dam Seepage Mitigation Project: On October 30, 2020, the Executive Director issued a water quality certification (certification) and adopted a Mitigated Negative Declaration for Pacific Gas and Electric Company's (PG&E) Lake Fordyce Dam Seepage Mitigation Project (Project). This Project is part of PG&E's Upper Drum-Spaulding Hydroelectric Project (Federal Energy Regulatory Commission Project No. 2310). The Project involves repairing Lake Fordyce Dam to bring it into compliance with the Division of Safety of Dam's seepage threshold. Instream Flow Related Work Under the California Water Action Plan: On October 16, 2020, Division of Water Rights staff released a *Draft Sensitivity Analysis Approach Memo for the Development of the Groundwater-Surface Water Model of the Ventura River Watershed* (Draft GSFLOW Sensitivity Analysis Approach Memo) for public comment. The Draft GSFLOW Sensitivity Analysis Approach Memo identifies the methodology that will be used to conduct a sensitivity analysis of the Ventura River Watershed groundwater-surface water modeling tool, which is under development by the State Water Board and Los Angeles Regional Water Quality Control Board. The deadline for comments is November 16, 2020. The Draft GSFLOW Sensitivity Analysis Approach Memo and additional information is available on the California Water Action Plan webpage, at:

As background, under an action in the California Water Action Plan the State Water Board and California Department of Fish and Wildlife identified five priority streams to enhance water flows to support anadromous fish. The five streams are: Mark West Creek, tributary to the Russian River; Mill Creek, tributary to the Sacramento River; Shasta River, tributary to the Klamath River; South Fork Eel River; and Ventura River.

<u>Upper Russian River Water Managers Meeting</u>: On October 21, 2020, Division of Water Rights staff presented at the Upper Russian River Managers Meeting. Topics staff covered and solicited feedback on included: an overview of a draft water availability analysis of the Russian River watershed for this dry season and related beta tool developed by staff; and an overview of preliminary surface water measurement reporting (Senate Bill 88) results.

Senate Bill 19 – Stream Gaging Plan: State Water Board staff meet bi-weekly with Department of Water Resources, California Department of Fish and Wildlife, and Department of Conservation staff to work on the development of a comprehensive Stream Gaging Plan for the state. On October 5, 2020 staff sent out emails to key stakeholders to request their participation on a Technical Advisory Committee that will help inform the effort. The first TAC meeting is scheduled for November 3, 2020. Don Pedro and La Grange Hydroelectric Projects: On October 2, 2020, Modesto Irrigation District and Turlock Irrigation District (collectively, Districts) filed a petition with the Federal Energy Regulatory Commission (FERC), requesting FERC find waiver of the State Water Board's water quality certification authority for the Don Pedro and La Grange Hydroelectric Projects (FERC Project Nos. 2299 and 14581). The Districts petition argues that denial of the certification applications is equivalent to the withdrawal and resubmittal process. On October 30, 2020, the State Water Board filed with FERC a motion to intervene and comments on the Districts' petition for declaratory order, disagreeing with the Districts' argument.

DIVISION OF DRINKING WATER

Permits

Permits are issued when a public water system undertakes action that may impact public health (i.e. a new source of supply, modifying treatment or adding a large distribution reservoir), when the original permit has numerous amendments, or following new regulations or conditions that DDW deems necessary for the protection of public health.

Violations & Enforcement Actions

Violations for a water system include whether the system has failed to follow established monitoring and reporting schedules, failed to comply with mandated treatment techniques, violated any Maximum Contaminant Levels, or failed to communicate required information to their customers. Enforcement Actions are used to obtain water system compliance with drinking water requirements to provide a safe and

reliable supply of water. The Division of Drinking Water's formal enforcement actions involve the use of statutory authority and includes issuance of citations and compliance orders.

Environmental Laboratory Accreditation Program (ELAP)

After adoption of new program regulations in May, ELAP launched a compliance assistance initiative, Roadmap to ELAP Accreditation, to assist laboratories in making the transition to new requirements that are anticipated to become effective on January 1, 2021. ELAP has held individual Transition Appointments for 47 laboratories prioritized based on certificate expiration date to answer questions and help them create their own transition plans. Each accredited laboratory will be offered an appointment. Twenty-five of the 47 laboratories are early adopters of the TNI Standard.

ELAP staff presented at a virtual workshop hosted by the California Water Environmental Association. ELAP discussed the new program regulations and provided information to help laboratories prepare for upcoming changes.

ELAP staff participated in the Association of State Drinking Water Administrators-Association of Public Health Laboratories PFAS State accreditation program work group.

Water Partnership Outreach -- Bishop, CA

State Water Resource Control Board hosted a two-part Water System Partnerships Pilot Workshop on October 22 and October 27, 2020 inviting the 30 water systems located within a five-mile radius of the city of Bishop. The workshop was the result of

collaboration efforts between many parties: Division of Drinking Water, Office of Public Participation, Mono-Inyo Integrated Regional Water Management, Local Primacy Agency- Inyo County, and U.S. EPA and its consultant Cadmus Group. The purpose of the Workshop was to increase awareness among participants for the importance of TMF capacity, and how partnerships could assist water systems to increase their capacity through collaboration and sharing existing resources. The feedback received from participants will be used to develop future partnerships materials.

Mandatory Consolidation Order Issued – Orosi PUD & East Orosi CSD Mandatory consolidations orders were issued on Oct. 27, 2020 to Orosi PUD and East Orosi CSD. The first deliverable is a draft consolidation plan by December 18 of this year and the final consolidation date is December 31, 2024.

West Water Company – Mandatory Consolidation/Administrator Public Meeting A public meeting webinar was held for West Water Company customers to seek input on potential mandatory consolidation of the water system with Sonoma County's Fitch Mountain CSA-41.

Drinking Water for Schools Grant Program

Completed Significant Events

A funding agreement with Rural Community Assistance Corporation was executed on October 21, 2020 in the amount of \$2,579,000 to provide technical assistance, and conduct outreach to implement interim drinking water solutions at schools serving disadvantaged communities.

Future Significant Events

Staff anticipate executing a funding agreement with Self Help Enterprises in the coming weeks.

Proposition 1 Stormwater Grant Program

Completed Significant Events

The Round 2 solicitation opened April 2020 and closed on July 2, 2020. There were a total of 67 proposals received. Proposals are currently under review.

Future Significant Events

Round 2 funding awards are anticipated by January 2021.

<u>Proposition 1 Groundwater Grant Program</u>

Completed Significant Events:

The majority of projects awarded as part of the Round 2 solicitation were executed during Summer 2020 (11 agreements executed, out of 13 total awards).

Future Significant Events:

The last two Round 2 projects are expected to be executed by the end of 2020. The Round 3 solicitation is tentatively planned to open Summer 2021.

<u>Proposition 68 Groundwater Treatment and Remediation Grant Program:</u>

Completed Significant Events:

A total of six projects were awarded funds (approximately \$40 million). Funding eligibility for additional drinking water project types was authorized at the August 18, 2020 State Water Board Meeting.

Future Significant Events:

Agreements for the six awarded projects are anticipated to be executed by June 2021. Also, according to the new authorities provided, staff are coordinating with the Office of Sustainable Water Solutions regarding potential allocation of remaining Prop 68 Groundwater funds to eligible drinking water projects.

Operator Certification Program

Completed Significant Events:

The Wastewater Operator Certification Program (WWOCP) is given authority in the California Water Code (sections 13625 – 13633) to administer examinations to operators of wastewater treatment plants. WWOCP is required to provide at least two examinations per year in accordance with California Code of Regulations, title 23, division 3, chapter 26, section 3701 subdivision (a). Due to COVID-19 concerns and shelter-in-place orders, the October 10, 2020 examination was cancelled.

During the month of October 2020, WWOCP proctored 57 emergency exams for operators at wastewater treatment plants experiencing compliance issues or potential compliance issues due to the main examination cancellation.

Future Significant Events:

WWOCP will continue to administer emergency examinations in groups under 10 throughout November and December for wastewater treatment plants that have compliance or potential compliance issues, and staffing issues due to the regular examination cancellation. The WWOCP is moving forward with computer-based testing implementation and is anticipating to having computer-based testing available to examinees in early 2021.

Marketing and Outreach

The Marketing and Outreach unit hosted the first virtual California Financing Coordinating Committee (CFCC) funding fair on October 22, 2020.

The CFCC funding fair provided the opportunity for the public to learn more about available grant, loan, and bond financing options for infrastructure projects from federal, state, and local agencies.

Representatives from water industry professionals, public works, local governments, and California Native American Tribes attended. This included city managers and planners, economic development and engineering professionals, officials from privately owned facilities, water and irrigation district managers, financial advisors, and project consultants.

OFFICE OF RESEARCH, PLANNING, AND PERFORMANCE

Water Conservation

The <u>Urban Water Conservation Reporting Regulation</u> became effective October 1, 2020. The *Public Stakeholder Webinar to Demonstrate Updates to The Urban Water Supplier Reporting Tool* was offered on September 22, 2020 and had over 250 participants in attendance. In addition, the Conservation Team has developed a Monthly Reporting Working Group to provide feedback on changes to the report and other supporting materials. The team plans to continue its partnership with the working group as we work towards data streamlining efforts required as part of the <u>2018 Water Efficiency Legislation</u>.

The response rate for the September Urban Water Conservation Report is 81% as of the writing of this report (331 out of 410 reports submitted). Of the submitted reports, 270 of the reports provide final production numbers, while 61 of the reports indicate that the production data is preliminary. The estimated total production (accounting for missing reports) is 187.35 billion gallons, and the statewide R-GPCD is 113 GPCD. 66 out of the 331 reports indicate that the reporter's agency is experiencing a water shortage greater than 10% of the agency's water supply.

COVID-19

The water shutoff reporting site, https://watershut-off.covid19.ca.gov/, received 24 reports for the month of October.

The Board and the California Public Utilities Commission held a virtual joint workshop on October 30, 2020 to discuss the financial impacts of COVID-19 on water systems and households. Panel members included representatives from water systems, community-based organizations, and water customers. Links to the workshop presentations are available at: https://www.cpuc.ca.gov/covid/

Water Loss Performance Standards

Staff participated in the American Water Works Association Fall conference to provide an update on the process and timeline of the water loss regulatory process.

OFFICE OF ENFORCEMENT

Garden Grove industrial facility penalized \$1.14 million for soil, groundwater contamination: The Santa Ana Regional Water Quality Control Board issued a \$1.14 million penalty against Cham-Cal Engineering Co. and Western Avenue Associates, L.P. for failing to comply with a 2016 Cleanup and Abatement Order. Cham-Cal, the operator and owner of a facility in Garden Grove that manufactures commercial truck accessories, used and stored tetrachloroethene (PCE) in its vapor degreasing operation, resulting in repeated discharges of the suspected cancer-causing contaminant to soil and groundwater on industrial property owned by Western Avenue Associates. The order required Cham-Cal and Western Avenue Associates to remediate the contaminated soil, soil vapor and groundwater beneath the facility and submit technical reports to the regional board. The companies instead failed to meet most of their deadlines and were penalized for submitting a late Interim Remedial Action Plan and neglecting to implement a Vapor Mitigation Plan to protect workers from inhaling PCE — a solvent the U.S. Environmental Protection Agency classifies as a probable human carcinogen.

City of Mount Shasta agrees to settlement for sewage spills and violations at wastewater treatment plant: The city of Mount Shasta has agreed to pay \$1.3 million to settle an Administrative Civil Liability complaint for multiple sanitary sewer overflows from its collection system and for violating effluent limitations at its wastewater treatment plant. The overflows, which occurred between October 2014 and April 2017, primarily were caused by a buildup of debris and root intrusion from aging infrastructure that could not accommodate heavy flows during intense rainfall. In 2017, the heavy rains also caused substantial channel bank erosion at a pipe crossing that resulted in failure of the pipe and a sewage spill into Cold Creek, tributary to Lake Siskiyou. Under the terms of the settlement, the city will allocate \$1.1 million of the penalty to upgrading the collection system in the downtown area to reduce the likelihood of future overflows.

<u>California Water Boards Performance Report</u> The 2019-20 California State Water Boards Annual Performance Report will be released on November 17, 2020. This will be the Twelfth year of the Performance Reports for the Regions and Programs of the Water Board. 2019-20 has seen some major changes to the Performance report as we worked to move many of the report cards into interactive dashboards. Staff is continuing to improve the functionality and accessibility of the Performance Report and will be working closely with programs to develop more outcome-based performance measures in the future.

California Bioassessment Working Group Meeting The 27th annual California Aquatic Bioassessment Working Group Meeting was on October 13 and 14, 2020. For the first time, this meeting was held and broadcasted virtually and it provided an opportunity to invite speakers globally and had attracted over 400 individuals to register, the most we've ever had. This meeting is held annually for researchers, policy-makers and implementers, educators and students to share and exchange information and research on freshwater science and bioassessment, support science-based policy to protect and restore California's freshwater aquatic ecosystems. We've received extremely positive feedback on how the meeting was run and that an opportunity to attend virtually was provided. Attendees were pleasantly surprised by our Keynote Speaker, Obi Kaufmann, who gave an inspiring speech and painted a fresh perspective on the complexities of California's water sources and ecosystems.

IRRIGATED LANDS REGULATORY PROGRAM UPDATE

October 2020

This month's Irrigated Lands Regulatory Program (ILRP) update provides a summary of significant activities of State Water Board staff from September 15, 2020 to October 15, 2020; and, the North Coast, San Francisco Bay, Central Coast, Los Angeles, Lahontan, Colorado River Basin, Santa Ana, and San Diego Regional Water Boards from August 15, 2020 to October 15, 2020. Next month's report will present activities of the Central Valley Water Board's Program and cover the time-period from September 15, 2020 to November 15, 2020.

State Water Board staff is working with professionals around the state on the California Nitrogen Management Certified Crop Advisors (CCA) Exam Committee to develop a special nitrogen course and exam that will allow CCAs to specialize in nitrogen management. The course will provide knowledge that will be beneficial to CCAs when certifying Irrigation and Nitrogen Management Plans (INMPs), as required by the precedential requirements of Order WQ 2018-002, State Water Board's review of the petition of Waste Discharge Requirements, General Order No. R5-2012-0116 for Growers Within the Eastern San Joaquin River Watershed that are Members of the Third-Party Group (ESJ Order). The nitrogen course will be offered by UC Davis at the end of 2020 and into 2021.

North Coast Regional Water Board staff is developing a permit to address discharges of waste from vineyards in the North Coast Region. Staff is working to complete the administrative draft of the permit and an initial study. The vineyard permit/waiver development process will include substantial outreach to stakeholders and consultation with local Tribal interests. Staff is continuing their work with stakeholders to discuss the December 2019 North Coast Board informational item that outlined the direction and potential content of the permit, as well as the development schedule. Staff plan to host public workshops in the winter of 2020 and during the public review period which is anticipated to occur in the fall/winter of 2021.

Staff also completed the administrative draft of the Smith River Plain Water Quality Management Plan (SRPWQMP), which addresses the water quality impacts associated with lily bulb cultivation. The Watershed Stewardship Team, a group comprised of local, state, and federal agencies, the Tolowas Dee-ni' Nation, and the lily bulb growers, completed their review and submitted comments to the Regional Water Board. Staff is reviewing those comments, making revisions, and will soon release a public review draft for comment. After further revisions to the SRPWQMP, the Regional Water Board's Executive Officer will consider approving the plan. Elements of the plan are already being implemented and full implementation of the plan will begin after Executive Officer approval.

San Francisco Regional Water Board staff is developing outreach strategies and enforcement priorities for the Vineyard Program and are preparing for annual invoicing. Staff is also working with the Third-Party groups, Resource Conservation Districts, and local Farm Bureaus to understand the impact of the recent North Bay fires on vineyard properties enrolled in the permit. This information will be incorporated into outreach

efforts and be used to help inform inspection priorities for the upcoming rainy season.

Central Coast Regional Water Board staff is continuing the development of Ag Order 4.0. Public workshops were held on September 10, 11, 23, 24, and October 22 and 23 to receive verbal public comment from stakeholders, to allow staff to provide an overview of the draft order and written public comments, and to provide the Regional Board the opportunity to consider and discuss the draft order and public comments and provide staff with direction on next steps. The series of public workshops continue on December 9 and 10, and the Regional Board will consider and discuss the draft order and public comments and provide staff with direction on next steps.

The next steps and timing for the development and adoption of Ag Order 4.0 are uncertain and will depend on a number of factors including but not limited to: the nature and extent of the Regional Board's direction to staff regarding how to proceed with the draft order; staff's ability to implement the board's direction within the confines of the requisite administrative, technical and public process and associated timeframes; future Water Board public meetings schedule; and the ability to meet the January 31, 2021 court ordered date to adopt Ag Order 4.0 or otherwise secure a court approved extension or extensions.

If the Regional Board directs staff to incorporate significant changes to Draft Ag Order 4.0, an additional public comment period likely will be necessary prior to the adoption hearing; in this case, a revised or proposed Draft Ag Order 4.0 will be made available for another round of written public comment and additional oral public comment will be part of any subsequent meetings leading up to and including the final adoption hearing. Staff anticipates knowing whether another written public comment period will be necessary after receiving direction from the board during the December workshop or later if the workshop is extended. Staff will provide formal responses to the public comments received in response to Draft Ag Order 4.0 and Draft Environmental Impact Report as part of the next steps for the development and adoption of a proposed order.

Los Angeles Regional Water Board's current agricultural waiver is set to expire in 2021 and staff is working on the staff report for the new waiver and continuing the monitoring data analysis for the period 2005-2020.

Earlier this year, the Natural Resources Conservation Service team located in Ventura County, submitted applications for the National Water Quality Initiative readiness phase for the Calleguas Creek and Ventura River watersheds. The Los Angeles Water Board staff and representatives from the United States Environmental Protection Agency, Ventura County Resource Conservation District and Ventura County Agricultural Irrigated Lands Group (VCAILG) participated in this effort. Both applications were approved by the United States Department of Agriculture. In addition, the team received a state award for partnership planning and will be honored at the California Association of Resource Conservation Districts conference in November 2020.

Los Angeles Water Board staff had several conference calls with Central Valley Water Board staff, the VCAILG, and the facilitator of the Expert Review Panel for the ESJ Order surface water quality monitoring program to share information requested by the Panel describing the scope and design of the Ventura County surface water

monitoring program. On August 25, 2020, the Los Angeles Water Board staff presented to the Panel via Zoom details of requirements of the Conditional Waiver (Order No. R4-2016-0143) for the Ventura County surface water monitoring, which was followed by a presentation by VCAILG describing the development of the monitoring program, the monitoring sites selection, the program cost, the source investigation and exceedance based monitoring, and individual discharge monitoring.

Lahontan Regional Water Board staff is working to develop a Staff Report that will be presented to the Regional Water Board during an informational item and workshop in January 2021. The report provides an overview of agricultural discharges in the Lahontan Region and assesses all existing permits in the region as compared to the precedential requirements of the ESJ Order. The report provides a series of identified actions to update the existing agricultural discharge permit so that it is consistent with the precedential requirements of the ESJ Order and outlines a series of actions for potential future development of commodity- and geographic-specific general orders. Staff will be seeking input and feedback from the Lahontan Regional Water Board and interested stakeholders during the January 2021 meeting. It will be an informational item and workshop and no action or approval will be taken by the Lahontan Water Board.

There are no significant program updates reported in the **Colorado River Basin**, **Santa Ana** and **San Diego Regions** from August 15, 2020 to October 15, 2020.

The Water Boards' Cannabis Cultivation Program (Cannabis Cultivation Program) update provides a summary of significant activities of the State Water Board's Division of Water Quality, Division of Water Rights, Office of Enforcement, and nine Regional Water Boards from August 15, 2020 to October 15, 2020. Additional information on the Cannabis Cultivation Program, including the <u>Cannabis Cultivation Policy – Principles and Guidelines for Cannabis Cultivation</u> (Cannabis Policy), <u>General Waste Discharge Requirements for Discharges of Waste Associated with Cannabis Cultivation Activities</u> (Cannabis Cultivation General Order), Cannabis Small Irrigation Use Registration (Cannabis SIUR), and enforcement efforts, is available on the <u>Water Boards Cannabis Cultivation Program webpage</u> at: https://www.waterboards.ca.gov/water issues/programs/cannabis/

STATE WATER RESOURCES CONTROL BOARD

Water quality staff in the Cannabis Cultivation Program has been reduced by approximately 50 percent due to funding shortfalls and a decision not to raise cannabis fees this year. The Water Boards' Cannabis Executive Oversight Committee (EOC) is in the process of developing recommendations on how the Cannabis Cultivation Program should prioritize its workload and reduce the scope of the program to accommodate these reduced staffing levels. The remaining staff in the Cannabis Cultivation Program will be focused on core regulatory functions including accepting applications, processing fees, issuing Notices of Applicability (NOAs) and outreach. Enforcement activities will be aimed at negative impacts from illegal cultivation sites.

COVID IMPACTS

The Cannabis Cultivation Program continues to perform essential services and provide support to stakeholders remotely during the COVID-19 emergency. The Water Boards are continuing their efforts to protect public health, safety, and the environment consistent with all federal, state, and local public health directives and guidelines related to COVID-19. The Cannabis Cultivation Program continues to accept applications, process fees, issue NOAs, and respond to and assist cannabis cultivators. However, for staff health and safety, the Cannabis Cultivation Program has limited site visits, access to the Water Rights Records Room, and in-person fee payments.

FIRE IMPACTS

The Glass Fire, August Complex Fire, LNU Lightning Complex, and other fire incidents resulted in evacuations of North Coast Regional Water Quality Control Board staff as well as areas with prevalent cannabis cultivation (https://www.newsweek.com/california-fires-august-complex-marijuana-cannabis-growers-refuse-evacuate-1534229). Most of the fires are now over eighty percent contained, however there are still some evacuations that are potentially impacting areas with prevalent cannabis cultivation.

COORDINATED OUTREACH - CANNABIS CULTIVATION PROGRAM

The July 22, 2020, online cannabis cultivation permitting workshop (online workshop) is now available online and includes audio voice-over translations into Spanish and Hmong. The three versions (English, Spanish, and Hmong) are available on YouTube and have been <u>advertised</u> on the Water Boards' Cannabis Cultivation Program website, Water Boards' Cultivation Program Facebook

(https://www.facebook.com/CAWaterBoardsCultivation/), on the <u>Water Boards'</u> <u>Cultivation Program Instagram</u> (https://www.instagram.com/cawaterboardscultivation/), and through the Cannabis Cultivators email subscription list. Other presenting regulatory agencies were notified of the completed voice-over efforts and have advertised the availability of the online workshop recordings. The Cannabis Cultivation Program continues to coordinate with partner agencies to provide outreach and enrollment content for cultivators, but time commitments have been reduced due to reprioritization of workload. INTERAGENCY COORDINATION - CANNABIS CULTIVATION PROGRAM

Water Boards staff continue to meet with staff from California Department of Fish and Wildlife (CDFW), California Department of Food and Agriculture's CalCannabis Division (CalCannabis), and other regulatory agencies to ensure ongoing coordination and collaboration. Due to COVID-19 impacts, many of the regularly occurring meetings were canceled. Topics of coordination include: Water Boards' implementation of the Cannabis Policy through the Cannabis Cultivation General Order and Cannabis SIUR Program; CalCannabis regulations and license requirements for cannabis cultivation; consolidation of CalCannabis, Bureau of Cannabis Control, and California Department of Public Health's Manufactured Cannabis Safety Branch to form the Department of Cannabis Control; opportunities to streamline cannabis application processes; CDFW's Lake and Streambed Alteration (LSA) Agreement; inspection and enforcement in priority watersheds; data sharing; and each agency's ongoing implementation efforts related to their cannabis cultivation programs. Specific interagency coordination activities are summarized in the table below.

STATE WATER BOARD - DIVISION OF WATER RIGHTS

Cannabis Small Irrigation Use Registration Program

As of October 15, 2020, cannabis cultivators submitted 836 applications for Cannabis Small Irrigation Use Registrations (SIURs), an increase of 13 from August 15, 2020. Cannabis cultivators have paid the required fees for 824 of these registrations and the Division of Water Rights has issued 670 Cannabis SIUR certificates, an increase of 19 since August 15, 2020. Eleven parties are more than 30 days late in paying the required filing fee. Eighty-seven applications have been canceled before certification because the cultivators:

- a. are no longer cultivating cannabis;
- b. identified use of an alternative source of water; or
- c. were unresponsive to staff's requests for follow-up.

Registration applications are submitted online via the <u>Cannabis Cultivation Program</u> Application Portal (https://public2.waterboards.ca.gov/cgo).

Enforcement

The Cannabis Enforcement Section (CES) continues to coordinate with the North Coast, Central Coast, and Central Valley Regional Water Boards; CalCannabis; CDFW; El Dorado County; and Trinity County on enrollment enforcement, illegal cannabis cultivation inspections, and compliance with each agencies Cannabis Cultivation Programs. From August 15 to October 15, 2020, the CES issued 18 inspection reports (Report) to cannabis cultivators and 16 Notice of Violation (NOV) letters to cannabis cultivators without a valid water right for cannabis cultivation. Each NOV and Report provides information on the Water Boards' Cannabis Cultivation Program, instructions for how to file a response to the NOV or Report, website links to the Water Boards' Cannabis Cultivation Program's website, and Cannabis SIUR and Cannabis Cultivation General Order requirements. The NOVs and Reports provide each landowner 30 days from the date of receipt to submit a response to the State Water Board or come into compliance by filing a Cannabis SIUR and/or enrolling in the Cannabis Cultivation General Order.

The CES continues to develop formal enforcement actions for cultivators who continue to cultivate and do not comply with the State Water Board's Cannabis Program after notice was provided.

Since August 15, 2020, the CES has conducted five priority enforcement related inspections coordinated with state and local partner agencies (four in El Dorado County, and one in Humboldt County).

COVID-19-related staff safety concerns and internal agency overnight travel limitations limit the CES from conducting a number of cannabis enforcement inspections on illegal cannabis sites. The CES continues to assess participation on multi-agency enforcement inspections based on high priority water right factors.

STATE WATER BOARD - DIVISION OF WATER QUALITY

Enrollment under the Cannabis Cultivation General Order increased by 172 enrollees between August 15 and October 15, 2020, bringing the total active Cannabis Cultivation General Order NOA count to 5,429. A total of 270 Cannabis Cultivation General Order applications were submitted during the reporting period. Cannabis Cultivation General Order and Cannabis SIUR applications are completed online via the Cultivation Program Application Portal (https://public2.waterboards.ca.gov/cgo).

A total of 153 enrollees have terminated enrollment under the Cannabis Cultivation General Order, an increase of three since August 15, 2020.

Staff is coordinating with the North Coast Regional Water Board to assist with application change requests and general customer service-related emails and phone calls from cultivators.

Staff continue to respond to CalCannabis regarding Cannabis Cultivation General Order NOA status and follow up with the appropriate Regional Water Board, as necessary.

STATE WATER BOARD - OFFICE OF ENFORCEMENT

From August 15 to October 15, 2020, the Office of Enforcement's Cannabis Enforcement Unit (CEU) has been teleworking and has participated in warrant inspections. Unit highlights include:

Inspections - CEU sent two staff for a one-day warrant inspection operation in Southern California with the Santa Ana Regional Water Board. The inspections were the first time the unit could test the COVID-19 inspection recommendations while in the field with other law enforcement and government agencies. CEU participated in seven inspections and authored reports for five sites.

Economic Benefit Assessment - CEU's first economic benefit assessment was submitted as part of a Central Valley Regional Water Board Cannabis Administrative Civil Liability (ACL) package for Hanover Properties, LLC that was heard at the October 15 Regional Board meeting. The unit additionally completed a request for economic benefit assessment from the North Coast Regional Water Board.

Regional Board Enforcement Prioritization and Planning - CEU met with staff, supervisors and management from the North Coast, Santa Ana, Central Valley, San Diego and Central Coast Regional Water Boards on topics such as enrollment enforcement by mail, enforcement prioritization, and high risk site disturbed area stabilization plans (DASPs).

Case Management - CEU staff managed formal enforcement referrals and informal enforcement follow-up on permitted and unpermitted site in collaboration with the Central Coast and North Coast Regional Water Boards.

Contact and Complaints - CEU received public contacts via voicemail and email regarding cannabis program complaints and questions. The unit responded or routed information received to the Division of Water Rights and the Central Valley Regional Water Board.

Correspondence - A Notice of Violation was re-issued by CEU to attempt contact with new property owners. A Notice of Violation was re-issued to resolve returned certified mail correspondence.

NORTH COAST REGIONAL WATER QUALITY CONTROL BOARD

From August 15 to October 15, 2020, North Coast Regional Water Board cannabis staff issued 96 NOAs for new enrollments (94 waste discharge requirements + two waivers) and re-issued 33 NOAs for existing enrollments under the Cannabis Cultivation General Order, issued 17 NOAs for instream work to be conducted under the Cannabis General Water Quality Certification, issued one individual Water Quality Certification, received two enrollment termination requests, conducted two site inspections, reviewed six technical reports, and issued one NOV, and one Cleanup and Abatement Order (CAO).

Due to the current COVID-19 pandemic, and in conformance with state and local orders, all cannabis regulatory and enforcement staff in the North Coast Region's Santa Rosa and Eureka offices are teleworking with remote network access.

As of October 15, 2020, there are approximately 3,187 active enrollments (3,039 waste discharge requirement enrollees + 148 waivers) under the Cannabis Cultivation General Order in the North Coast Region. These numbers represent approximately 59 percent of total enrollments statewide, including approximately 77 percent of non-waiver enrollments. Staff is currently processing 40 new applications for enrollment. Since the North Coast Region's last update to the Executive Director, staff has received approximately 59 voicemails and 432 emails from applicants, enrollees, automated systems, and members of the public in the North Coast Region's general inboxes. On October 15, 2020, at the North Coast Regional Water Board meeting, staff (joined by Jonathan Bishop) provided a Cannabis Program update. SAN FRANCISCO BAY REGIONAL WATER QUALITY CONTROL BOARD

From August 15 to October 15, 2020, San Francisco Bay Regional Water Board staff issued three NOAs. As of October 15, 2020, there are 190 active enrollments (26 waste discharge requirement enrollees and 164 waivers) under the Cannabis Cultivation General Order in the San Francisco Bay Region. Staff is currently processing 10 new applications for enrollment.

San Francisco Bay Regional Board staff has been teleworking since March 16, 2020 due to the current COVID-19 pandemic.

CENTRAL COAST REGIONAL WATER QUALITY CONTROL BOARD

From August 15 to October 15, 2020, Central Coast Regional Water Board staff issued 16 NOAs, re-issued nine NOAs, processed or continued processing 29 proposals for restoration and stabilization work, issued two approval letters for restoration and stabilization work, and issued 30 NOVs. Additionally, two sites were brought into compliance with the riparian setback requirements through implementation of their Disturbed Area Stabilization Plans and the risk for the sites was decreased from high risk to low risk.

Staff issued 15 directives to obtain regulatory coverage pursuant to Water Code section 13260. Sites were identified through coordination with law enforcement and analysis of aerial imagery. Staff continue to coordinate with law enforcement and local agencies to identify additional unenrolled sites.

SOUTH COAST REGIONAL CANNABIS UNIT

From August 15 to October 15, 2020, South Coast Regional Cannabis Unit staff representing the Los Angeles, Santa Ana, and San Diego Regional Water Boards issued six NOAs. To unpermitted illicit sites, staff issued one approval letter for site restoration and stabilization, provided local law enforcement agencies with 43 enrollment checks via email, and continued to draft NOVs and CAOs with the Office of Enforcement assistance. On September 23, 2020, staff participated in a mid-scale illicit cannabis operation led by the Riverside County Sherriff's Department. The operation served search warrants at approximately 60 unpermitted illicit cannabis cultivation sites in the Anza/Aguanga area. Staff and the Office of Enforcement were present and inspected 14 illicit sites that represented the greatest impact to water quality during the operation.

Staff is currently processing 13 new applications for enrollment and approximately 200 NOVs to unpermitted illicit sites. NOVs and/or CAOs for four unpermitted illicit sites are in draft. Staff is working with the Office of Enforcement to develop a Rapid CAO template to address the 200-plus unpermitted illicit sites that have been inspected in the South Coast Region. As of October 15, 2020, three sites have been identified to use as a pilot for the Rapid CAO. Staff continue to provide enrollment checks via email to local law enforcement agencies a few checks per week.

As of October 15, 2020, there are 564 active enrollments under the Cannabis Cultivation General Order in the South Coast Region. Staff has issued four total NOVs to unpermitted illicit sites; two sites have been approved for site restoration and stabilization and two NOVs remain pending contact with the responsible parties and proposals for site restoration and stabilization.

Due to the current COVID-19 pandemic, and in conformance with state and local orders, South Coast staff is teleworking with remote network access. Staff is performing limited inspections of unpermitted illicit sites and prioritizing sites with the greatest impact to water quality.

CENTRAL VALLEY REGIONAL WATER QUALITY CONTROL BOARD

From August 15 to October 15, 2020, Central Valley Regional Water Board staff issued 53 NOAs (with dozens more currently in process for Lake County), processed two enrollment termination requests, conducted three compliance inspections, and five enforcement inspections. Staff participated in two outreach events in Nevada County. Staff has identified approximately 20 permitted and five enforcement sites that were impacted by fires in summer 2020. Staff brought two ACL cases to the Board. One was heard at the October Regional Board meeting and resulted in the ACL Order adoption. A second ACL case is in final stages of settlement negotiations and the site has been remediated.

The Central Valley Regional Water Board Cannabis Program Manager presented a Program Update for the Central Valley Board on October 16, 2020. The update included a discussion of the staff reduction statewide by the Office of Enforcement and concluded with a discussion of how the reduction in resources will be managed through improved efficiency and interagency coordination.

A surge in enrollment applications from Lake County in October has resulted in staff preparing dozens of NOAs which are currently in process. The applications are the result of a county-imposed deadline of October 31, 2020 in an effort to curtail new county Use Permit applications.

Staff continues to coordinate with local law enforcement and CDFW in an effort to triage enforcement inspections.

On September 1, 2020, the Enforcement Unit and the Permitting/Compliance Unit merged into a single Cannabis Regulatory Enforcement Unit under one senior in the Redding office as a result of the staff reductions. Two staff and one senior were reassigned to other vacancies in the Redding office and the existing vacancies were eliminated. The Rancho Cordova office had one vacancy eliminated and a second vacancy defunded.

Staff has identified numerous barriers to enrollment, some varying by county. Some counties have not established a programmatic CEQA process, others have upper limits on number of use permits they will issue, others are understaffed and can only process a small amount of use permits per month. A major barrier to enrollment in general is the small number of permissive counties in the Central Valley.

EASTERN CALIFORNIA REGIONAL CANNABIS UNIT

From August 15 to October 15, 2020, Eastern California Regional Cannabis Unit staff, representing the Lahontan and Colorado River Basin Regional Water Boards, issued ten NOAs and conducted one virtual inspection. Staff continued to work on settlement for three ACL complaints in the Colorado River Basin Region and one CAO in the Lahontan Region. Staff continue to provide enrollment verification checks for CDFW and county law enforcement. As of October 15, there are 260 active enrollments, 121 in Region 6 and 139 in Region 7.
