NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT, STAFF-LEVEL WORKSHOP, AND BOARD HEARING

DRAFT UTILITY WILDFIRE AND SIMILAR OPERATIONS AND MAINTENANCE ACTIVITIES CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND WASTE DISCHARGE REQUIREMENTS GENERAL ORDER AND ASSOCIATED CEQA EIR

NOTICE IS HEREBY GIVEN that comments will be accepted by the State Water Resources Control Board (State Water Board) on the draft Utility Wildfire and Similar Operations and Maintenance Activities Clean Water Act Section 401 Certification and Waste Discharge Requirements General Order (Utility Wildfire General Order) and supporting Environmental Impact Report (EIR). Pursuant to CEQA, the State Water Board is the Lead Agency and has prepared an EIR for the Utility Wildfire General Order. The comment period starts June 28, 2024. Comments must be received by the Board Clerk by 12:00 p.m. (noon) on ~~August 30, 2024~~ **September 13, 2024**.

The Utility Wildfire General Order covers electric utility wildfire prevention, response, and other similar routine operation and maintenance activities that may cause or threaten to cause a discharge of waste into waters of the state. For additional information, reference the “GENERAL ORDER DESCRIPTION” section below. The EIR identifies potential significant impacts to aesthetics, cultural resources, and tribal cultural resources.

PUBLIC HEARING PARTICIPATION

Comments will be accepted in person and remotely during the Board Hearing. Members of the public interested in remotely joining the public hearing or providing oral comments, please follow the [remote participation guidelines](#). Registration is not required to view the live webcast. Participants will be given an opportunity to provide oral presentations. To ensure a productive and efficient Board workshop, the Board may limit time for oral presentations.

The Board will not consider adoption of the Utility Wildfire General Order at Board Hearing. A quorum of the Board will be present; however, the Board will not take any action at the public hearing. There will be no sworn testimony or cross-examination of interested persons. However, the State Water Board and its staff may ask clarifying questions.

GENERAL ORDER DESCRIPTION

Senate Bill 901 (Dodd, 2018) was passed in response to the increasing frequency and intensity of California’s wildfires. This bill included Wildfire Mitigation Plan requirements to increase the pace and scale of utility work to prevent, combat, and respond to wildfires affecting utility service territories. Wildfire Mitigation Plan activities have the potential to discharge waste that can adversely impact water quality and impair beneficial uses.

The Utility Wildfire General Order would provide an expedited process for permit coverage of related utility activities and support essential wildfire prevention and mitigation activities. The Utility Wildfire General Order also proposes to cover similar activities that may be performed outside high-fire threat areas and/or unrelated to wildfire prevention.

The specific types of activities covered are listed below:

- Vegetation Management
- Herbicide Application
- Site access development and maintenance
- Staging Areas and Laydown Yards
- Pole/Tower Repairs or Replacement
- Substation Maintenance
- Transmission Tower Maintenance
- Structural Conversion
- Line Reconductoring
- Undergrounding Powerlines
- Boardwalk Repairs or Replacement
- Electric Utility Infrastructure Lowering, Maintenance, Replacement or Removal
