BACKGROUND

This workshop will provide an opportunity for stakeholders to learn about the State Water Board's 2025 Safe Drinking Water Plan which is a Legislative report required by [Health and Safety Code Section 116355](#). The State Water Board will provide an overview of the document, highlight progress made since the 2020 Safe Drinking Water Plan, and describe the goals in the 2025 Safe Drinking Water Plan.

The Health and Safety Code Section 116355 describes the topics required in the Safe Drinking Water Plan, which the State Water Board must report on every 5 years, including:

- An assessment of the overall quality of the state's drinking water,
- Identification of specific water quality problems,
- Analysis of known and potential health risks, and
- Actions the State Water Board is undertaking to improve drinking water quality and recommendations for continued improvements to California's drinking water.
