Kickoff Workshop:

Goals, Status, and Path Forward for Vapor Intrusion at Cleanup Sites

The California Environmental Protection Agency (CalEPA) Vapor Intrusion Workgroup (CalEPA VI Workgroup) is a multi-agency workgroup consisting of the Department of Toxic Substances Control (DTSC), the State Water Resources Control Board (State Water Board), the Regional Water Quality Control Boards, and the Office of Environmental Health Hazard Assessment (OEHHA) that serves as a technical and regulatory resource for addressing contaminated sites impacted by vapor intrusion across California. The CalEPA VI Workgroup is planning a series of public workshops to gain input on CalEPA's efforts to evaluate vapor intrusion at contaminated sites. The Kickoff Workshop will be hosted via Zoom on July 24, 2025, from 9:00 am-12:00 pm PDT – this will be a virtual-only workshop with no physical location.

The Kickoff Workshop will provide an update of CalEPA's key vapor intrusion evaluation tools and strategies and outline the agency's planned path forward. The Kickoff Workshop will also include a public panel discussion and breakout sessions. The panel discussion will provide different public perspectives and viewpoints relating to the investigation, cleanup, and decision-making regarding vapor intrusion at contaminated sites. The panel members will include representatives from the environmental justice community, brownfield redevelopment, industry and academia. The goal of the breakout sessions is for CalEPA to gain feedback on specific vapor intrusion topics to inform and improve the content of future workshops in the series. The breakout sessions will be held simultaneously; participants will be asked to choose one topic of interest during the workshop and will be placed in their chosen breakout session.

Background

The Kickoff Workshop is an introduction to a series of technical workshops that are tentatively planned for September 2025 through February 2026. The series will focus on meaningful engagement with the public on efforts to holistically approach evaluating and addressing vapor intrusion at contaminated sites using available guidance documents, best practices, and site-specific lines of evidence in decision-making. The CalEPA Final Draft Supplemental Guidance for Screening and Evaluating Vapor Intrusion (SVIG), Supplemental VI Guidance Final Draft, was released in February 2023, and is one of the most widely used tools across California for evaluating vapor intrusion at contaminated sites. Since its release, CalEPA has been actively engaged in training staff on utilizing the SVIG as well as additional tools and approaches needed to improve decision-making beyond the initial vapor intrusion screening evaluation. The CalEPA VI Workgroup is hosting this workshop series to update the public on its efforts and hear feedback. The future technical workshops in the series will provide an opportunity for the public to provide focused feedback to the CalEPA VI Workgroup.
