REVISED NOTICE OF PUBLIC HEARING MEETING

TO CONSIDER APPROVING AN AMENDMENT TO THE
WATER QUALITY CONTROL PLAN FOR THE CENTRAL COASTAL BASIN
TO ESTABLISH TOTAL MAXIMUM DAILY LOADS FOR ORGANOPHOSPHATE
PESTICIDES AND TOXICITY IN THE LOWER SALINAS RIVER WATERSHED,
MONTEREY COUNTY, CALIFORNIA

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will hold a public meeting to consider adopting a resolution to approve amendments to the Water Quality Control Plan for the Central Coastal Basin (Basin Plan) to establish Total Maximum Daily Loads (TMDLs) for three organophosphate pesticides, additive toxicity of those pesticides, and toxicity in the lower Salinas River watershed (Basin Plan amendment) and supporting Substitute Environmental Documentation (SED).

BACKGROUND

On June 21, 2024, the California Regional Water Quality Control Board, Central Coast Region (Central Coast Water Board) adopted Resolution R3-2024-0002 to amend the Basin Plan to establish TMDLs for organophosphate pesticides, additive toxicity of those pesticides, and toxicity in the lower Salinas River watershed (TMDL Project).

The TMDL Project establishes numeric targets, assigns TMDL allocations to sources of organophosphate pesticides in the watershed, and describes an implementation plan to achieve those allocations.

The TMDL numeric targets define the conditions necessary to protect designated beneficial uses of waters. This TMDL Project establishes the following numeric targets:

- Acute and chronic numeric targets for three organophosphate pesticides (chlorpyrifos, diazinon, and malathion) when present individually.
- An additive toxicity numeric target when two or more of these organophosphate
 pesticides are present in the water column because these three pesticides share
 the same mechanism of toxic action and result in additive toxicity to aquatic
 invertebrates.
- An aquatic toxicity numeric target stated as the following: "No significant toxic effect to the survival or sublethal (i.e., growth, reproduction, etc.) test endpoint."

This TMDL Project establishes the following TMDL allocations:

- Concentration-based TMDL allocations that are the same as the organophosphate pesticide numeric targets and expressed as concentrationbased TMDL allocations in the receiving water.
- Additive toxicity TMDL allocations that are the same as the organophosphate pesticide additive toxicity numeric target and expressed as the sum of each organophosphate pesticide divided by its concentration-based numeric target.

The TMDL allocation attainment date is December 31, 2032. This date is consistent with the compliance dates established in the General Waste Discharge Requirements for Discharges from Irrigated Lands, Order R3- 2021-0040 (Agricultural Order).

Implementation of this TMDL Project will rely on existing permits and their future renewals or modification, including stormwater permits and orders regulating discharges from agricultural operations, cannabis operations, and pesticide handling facilities.
