## Notice of Opportunity for Public Comment and Board Consideration of Adoption of an Order Acting on Petitions for Reconsideration for the McCloud-Pit Hydroelectric Project Water Quality Certification

State Water Resources Control Board (State Water Board or Board) staff will accept comments from the date of this Notice until 12:00 pm (noon) on ~~Wednesday, May 13,~~ **Tuesday, May 19,** 2026, on a Draft Order Granting In Part and Denying In Part Petitions for Reconsideration and Certifying a Final Subsequent Environmental Impact Report (Draft Order) for the Pacific Gas and Electric Company's (PG&E) McCloud-Pit Hydroelectric Project (Project) water quality certification (certification) issued on November 8, 2019. Additionally, the State Water Board will conduct a Board Meeting on June 17, 2026, to consider, among other items, adopting the Draft Order and final subsequent environmental impact report (SEIR). Additional information about the Project and how to provide comments on the Draft Order is provided below.

### **Ex Parte Disclosure Requirements**

Reconsideration of the Project certification is subject to the prohibition on ex parte communications, as described in a [Memo from the State Water Board's Office of the Chief Counsel](#).<sup>1</sup> In general, communications about certain pending matters, such as reconsideration of the Project certification, in the absence of other parties and without notice and opportunity for all parties to participate in the communication are prohibited. Any communications regarding reconsideration of the Project certification (except for non-controversial procedural matters) must occur at a publicly noticed meeting or workshop or be submitted to the Clerk to the Board in writing.

### **Background**

PG&E owns and operates the Project, which is located on the McCloud and Pit Rivers in Shasta and Siskiyou Counties. The Project is undergoing relicensing before the Federal Regulatory Energy Commission (FERC). The original FERC license for the Project expired on July 31, 2011. Since then, the Project has operated under annual licenses issued by FERC.

PG&E applied to the State Water Board for a Project certification on November 9, 2018. (33 U.S.C. § 1341.) The State Water Board prepared an initial study and negative declaration for the Project under the California Environmental Quality Act (CEQA) to inform and support its decision regarding PG&E's certification application for the Project's FERC relicensing. The State Water Board, acting through its Executive Director, issued a final initial study and negative declaration and a certification for the Project on November 8, 2019.

On December 6, 2019, PG&E (separately) and the Winnemem Wintu Tribe and North Coast Rivers Alliance (NCRA) (jointly) filed the petitions for reconsideration (Petitions) with the State Water Board. Each petition requests changes to the Project certification, and the Winnemem Wintu Tribe and NCRA's petition additionally challenges the CEQA analysis prepared for the Project certification. In response to the Petitions, the Executive Director directed staff to reinitiate consultation with California Native American tribes affiliated with the geographic area of the Project to inform whether, and if so, what additional CEQA work may be necessary ([Order WQ 2020-0041-EXEC](#)<sup>2</sup>). In 2021, the

Board reinitiated consultation with the Winnemem Wintu Tribe and staff determined that preparation of a SEIR would be appropriate to analyze impacts to tribal cultural resources that were unknown during the original CEQA process.

A [Notice of Preparation](#)<sup>3</sup> for the SEIR was issued on March 10, 2022. The [Draft SEIR](#)<sup>4</sup> was released on April 7, 2026.
