NOTICE OF DOCUMENT AVAILABILITY, OPPORTUNITY FOR PUBLIC COMMENT, AND PUBLIC HEARING

FOR THE AMENDMENT TO THE WATER QUALITY CONTROL POLICY ON THE USE OF COASTAL AND ESTUARINE WATERS FOR POWER PLANT COOLING

TO EXTEND THE COMPLIANCE SCHEDULE FOR ALAMITOS, HUNTINGTON BEACH, ORMOND BEACH, AND SCATTERGOOD GENERATING STATIONS

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will receive comments on the Draft Amendment to the Water Quality Control Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling to Extend the Compliance Schedule for Alamitos, Huntington Beach, Ormond Beach, and Scattergood Generating Stations (OTC Policy Amendment) and Draft Staff Report. The OTC Policy Amendment also includes a change without regulatory effect to revise the compliance date for Diablo Canyon Nuclear Power Plant.

The State Water Board will release these documents for public comment on or before **January 31, 2023**. Written comments must be received no later than **12:00 noon on March 17, 2023**. See below for additional information.

The proposed amendment to the Water Quality Control Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling (Once-Through Cooling or OTC Policy) would extend the compliance date for the following power plants:

- Alamitos Generating Station (Alamitos) Units 3, 4, and 5; Huntington Beach Generating Station (Huntington Beach) Unit 2; and Ormond Beach Generating Station (Ormond Beach) Units 1 and 2 for three years, from December 31, 2023, to December 31, 2026, to support system-wide grid reliability; and
- Scattergood Generating Station (Scattergood) Units 1 and 2 for five years, from December 31, 2024, to December 31, 2029, to support local system reliability.

The proposed amendment would also include a change without regulatory effect to revise the compliance date for Diablo Canyon Nuclear Power Plant (Diablo Canyon) Units 1 and 2 to October 31, 2030, to comport with the extension provided by Senate Bill 846.

BACKGROUND

The State Water Board adopted the [OTC Policy](#) on May 4, 2010 (effective date October 1, 2010), and amended it several times, with the last amendment on October 19, 2021 (effective date December 23, 2021). The OTC Policy includes technology-based standards to implement federal Clean Water Act section 316(b), which requires that the location, design, construction, and capacity of cooling water intake structures reflect the best technology available for minimizing adverse environmental impacts. The OTC Policy includes compliance dates for power plants using once-through cooling technology with orderly retirements and replacement of capacity aimed at maintaining local and system-wide electrical grid reliability in the State of California. Of the nineteen power plants originally covered by the OTC Policy, eleven have either retired, repowered, or have come into final compliance.

The joint-agency Statewide Advisory Committee on Cooling Water Intake Structures (SACCWIS) was created to advise the State Water Board on the implementation of the

OTC Policy, ensuring compliance schedules take into account the reliability of California's electricity supply, including local area reliability, statewide grid reliability, and permitting constraints.

Recent events have resulted in the need to consider extending OTC power plant compliance dates to address both system and local reliability.

On September 30, 2022, the SACCWIS recommended the State Water Board extend the compliance dates for Alamitos, Huntington Beach, and Ormond Beach to address system-wide grid reliability concerns associated with the following circumstances. The California Public Utilities Commission, California Energy Commission, and California Independent System Operator conducted a reliability analysis in May 2022 that considered impacts from extreme weather events, wildfires, supply chain constraints, interconnection and permitting concerns, and improved climate change updates in the electricity demand forecast. The analysis also considered the potential for coincidental events that could further adversely affect system-wide reliability, such as a simultaneously occurring heat wave, drought, and wildfire affecting transmission capacity. The resulting conclusions of this analysis identified a need for resource capacity beyond existing required planning criteria. Specifically, this new analysis identified a projected shortfall up to 10,000 megawatts in summer 2025. In recognizing these issues, the State Legislature subsequently adopted, and the Governor signed Assembly Bill 205, which created a statewide Electricity Supply Strategic Reliability Reserve Program to bolster system reliability while California procures clean energy resources, including extending the operations of power plants currently scheduled for retirement.

Also on September 30, 2022, the SACCWIS reviewed a request from the Los Angeles Department of Water and Power (LADWP) to extend the OTC Policy compliance date of Scattergood for five years from December 31, 2024, to December 31, 2029. The extension would provide time for planning, permitting, procurement, and construction of a new, non-OTC power plant at the Scattergood site and transmission infrastructure projects to ensure local grid reliability while LADWP transitions to zero-carbon energy. SACCWIS reviewed the LADWP's extension request and supporting documentation and found no cause for objecting (although the California Air Resources Board abstained from weighing-in on the request to evaluate it further). The SACCWIS therefore approved the [2022 Special Report of the SACCWIS](#), which includes alternatives and support for the LADWP's request to extend the OTC Policy compliance date for Scattergood for five years to support local grid reliability.

The proposed amendment to the OTC Policy would extend the compliance dates for Alamitos, Huntington Beach, Ormond Beach, and Scattergood generating stations per the recommendations and statements of support of the SACCWIS to support grid reliability.

The proposed amendment would also include a change without regulatory effect to revise the compliance date for Diablo Canyon. This change will ensure the OTC Policy is consistent with the compliance date that was already extended by SB 846, which was approved by Governor Gavin Newsom on September 2, 2022, to support statewide grid reliability.


