State Water Resources Control Board November 19, 2013 Item 5 - Executive Director's Report

DIVISION OF FINANCIAL ASSISTANCE

Marketing and Outreach:

California Financing Coordinating Committee: State Water Board staff participated in the California Financing Coordinating Committee (CFCC) Funding Fair on October 15, 2013 in Sacramento, at the Cal/EPA Building. The CFCC is comprised of seven member agencies (five state and two federal). Member agencies conduct funding fairs each year to educate interested parties about the CFCC and the financial and technical resources available for infrastructure projects. The member agencies are in the process of planning the 2014 Funding Fairs. Information regarding the CFCC can be found at: www.cfcc.ca.gov.

Infrastructure Funding Needs in Disadvantaged Communities: On November 6, 2013, State Water Board staff provided information on funding infrastructure needs in urban disadvantaged communities in Los Angeles to local elected officials.

Program Activity:

<u>Clean Water State Revolving Fund (CWSRF)</u>: Between the dates of October 9, 2013 and November 5, 2013, the Deputy Director approved the following Preliminary Loan/Grant Commitments:

- On October 18, 2013, Determination No. 2013-29 approved \$500,000 in CWSRF Small Community Grant funds for Planning Financing for the Eastern Municipal Water District's Quail Valley Subarea 9, Phase 1 Project; CWSRF No. C-06-7889-110.
- On October 21, 2013, Determination No. 2013-25 approved \$3,633,400 in CWSRF financing for the Orange County Water District's Fletcher Basin Improvement Project; CWSRF No. C-06-2013-25.
- On October 21, 2013, Determination No. 2013-34 approved \$5,255,000 in CWSRF financing and \$2,500,000 in Seawater Intrusion Control Program financing for the Orange County Water District's Alamitos Barrier Improvement Project; CWSRF No. C-06-7868-110 and SWIC No. SWI-3029-110.
- On October 22, 2013, Determination No. 2013-26 approved \$4,300,000 in CWSRF financing for the City of San Mateo's 25th Avenue Sanitary Sewer Relief Line Project, CWSRF No. C-06-7858-110.

<u>Office of Operator Certification Advisory Committee</u>: The Office of Operator Certification received a nomination representing municipalities from the League of California Cities to appoint Josh Vieira to replace a member of the nine-member Office of Operator Certification Advisory Committee (Advisory Committee) for the remainder of the period beginning July 1, 2010 and ending June 30, 2014. Consistent with the State Water Board's delegation to the Executive Director in Resolution No. 2012-0061, on October 25, 2013, the Executive Director authorized the appointment of Josh Vieira to the Advisory Committee.

<u>Clean Beaches Initiative Grant Program</u>: Approximately \$35 million remains available for the Clean Beaches Initiative Grant Program. The Division of Financial Assistance (DFA) temporarily closed the Clean Beaches Initiative grant program solicitation on August 8, 2013 to review submitted proposals. The Clean Beaches Task Force met on October 11 and 15, 2013 to review the applications and determine which proposals to invite to submit a detailed application. Four Implementation and two Research Project proposals were invited back. The solicitation has now re-opened until January 13, 2014 to allow additional applications for Implementation Projects to be submitted.

Integrated Regional Water Management (IRWM) Proposition 50, Chapter 8 IRWM Program

Implementation Grant: The State Water Board's Proposition 50 Integrated Regional Water Management (IRWM) Grant Program previously funded three projects in the Kings River Conservation District (KRCD). KRCD received \$6.064 million in Proposition 50 Round 1 Grant funds to implement: 1) Alta Irrigation District Traver Groundwater Recharge and Banking Project, 2) Fresno Irrigation District Jameson Pond Expansion Project, and 3) City of Fresno Residential Water Meter Installation Project. The projects address water management priorities identified by the Kings Basin Integrated Regional Water Management Plan (IRWMP) developed by a collection of Kings Basin agencies, stakeholders and individuals to improve coordination and collaboration on regional water management. KRCD's IRWMP goals include water reuse, halting and ultimately reversing groundwater overdraft, and increasing water supply quality, reliability and efficiency. The projects have been completed and final payment was sent to KRCD in October 2013.

DIVISION OF WATER QUALITY

Antidegradation Policy Review: State Water Board staff continued discussions with stakeholders regarding the Antidegradation Policy. The last two of six focused stakeholder meetings were held in November with representatives from site cleanup groups and food processors/wineries. The stakeholders continued to offer their ideas about possible revisions or guidance to improve the usefulness of the Antidegradation Policy for making informed decisions about discharges that affect groundwater. State Water Board staff will summarize comments received and take them under advisement for possible future action.

<u>Underground Storage Tank Program (UST)</u>: U.S. EPA in-kind-service contractor, the Sullivan Group (Sullivan), has finalized a plan to address the more than 300 properties in the State that have abandoned USTs. Sullivan will be preparing notices of violation which will be sent by the State Water Board to the owners of the properties with these abandoned USTs. Sullivan will then follow up with property owners to facilitate resolution of the issue with the appropriate local regulatory agency. Caltrans Municipal Separate Storm Sewer System (MS4), National Pollutant Discharge Elimination System (NPDES) Permit – Areas of Special Biological Significance (ASBS):

The NPDES Permit requires Caltrans to submit a final ASBS Compliance Plan to the State Water Board on September 20, 2014. Due to the lack of monitoring data to inform development of the Compliance Plan, Caltrans has requested a one year time extension for submittal of the plan. A public notice requesting comments on the proposed time extension was circulated in mid-November with the public comment deadline in December. After review of the public comments, the Executive Director will determine if the time extension can be administratively approved.

Division of Water Quality's 2013/14 Performance Targets: This month, the Division of Water Quality has included Performance Targets in Appendix A at the end of this report.

<u>State Water Board Irrigated Lands Regulatory Program (ILRP)</u>: This month's ILRP report is included in Appendix B at the end of this report.

<u>Statewide Policies/Significant General Permits:</u> This month's Policy and Permits Table is included in Appendix C at the end of this report.

DIVISION OF WATER RIGHTS

Sacramento River Tributaries Tour: On October 16-17, the California Department of Fish and Wildlife hosted watershed tours of Butte Creek and the Sutter Bypass, Deer Creek, Mill Creek, and Antelope Creek. Tour attendees included representatives from the Division of Water Rights, and the non-profit organizations American Rivers and the National Fish and Wildlife Foundation (NFWF). The purpose of the tour was to familiarize staff with the tributaries and the status of Chinook salmon populations in each tributary, with a focus on the major water diversion structures and potential barriers to salmonid migration. NFWF is looking for opportunities to establish a water transfer/acquisition program in the Central Valley, and NFWF staff was particularly interested in understanding the potential for such a program to succeed.

<u>Updates Related to the Klamath Hydroelectric Project (Federal Energy Regulatory</u> <u>Commission Project No. 2082)</u>: There are two updates for the Klamath Hydroelectric Project (Project): (1) water quality certification; and (2) October 16, 2013, Interim Measures Implementation Committee (IMIC) meeting. See below for more information on each item.

Water Quality Certification: PacifiCorp is on schedule to submit the Project's updated water quality certification application by August 15, 2014. Water quality certification Sections 2.0 (General Project Information) and 3.1 (Existing Project Facilities and Operations) are due December 13, 2013. State Water Board staff will review and comment (if necessary) on the section submittals.

IMIC Meeting: The IMIC met in Yreka, California on October 16, 2013. The meeting included a discussion of interim measure (IM) 10 (Water Quality Conference) and IM 11 (Water Quality Improvements). The purpose of the IMIC is to collaborate with PacifiCorp on issues related to the implementation of the IMs set forth in the Klamath Hydroelectric Settlement Agreement:

- **IM 10.** The Final IM 10 Water Quality Improvement Report (Report) was completed on September 4, 2013. The Report provides an overview of current conditions in the Klamath River system and identifies several pilot projects designed to evaluate treatment technologies that could improve water quality. Conceptual designs were prepared for the following pilot projects:
 - A. Diffuse Source Treatment Wetland Rehabilitation: Pilot project involves many small dispersed wetlands along the Sprague or Wood Rivers (tributaries to Upper Klamath Lake). The wetland would capture nutrients from natural and anthropogenic sources.
 - B. Large Scale Wetlands: Restoring large scale wetlands along Upper Klamath Lake and/or Keno impoundment. The wetlands would include habitat for endangered shortnose and Lost River sucker.
 - C. Sediment Removal through Dredging: Dredging the top 30 centimeters of a high concentration phosphorous area in Upper Klamath Lake and using the material for wetland rehabilitation, farm land soil amendment, or levee repair.
 - D. Sediment Sequestration of Phosphorus and Aeration/Oxygenation: Injection of alum micro-floc along with aeration into a section of Lake Ewauna in the Keno impoundment.

The pilot projects range in cost from \$230,000 to \$21,000,000 with a project life (including monitoring) of three to seven years.

- IM 11. PacifiCorp provided an update to the IMIC regarding 2013-2014 IM 11 projects. Below are updates of various IM 11 project.
 - (1) Algaecide Pilot Test: PacifiCorp conducted an algaecide application pilot project in Long Gulch of Iron Gate Reservoir. Two algaecide applications were performed; results are expected in April 2014.
 - (2) Panning and Design for a Demonstration Wetlands Facility Adjacent to the Klamath River: PacifiCorp is working with a Technical Advisory Committee (TAC) comprised of IMIC members with expertise in demonstration wetlands to identify potential wetland locations and designs.
 - (3) Continued development of the Water Quality Accounting Framework: PacifiCorp is working with the Klamath Tracking and Accounting Program (KTAP) to select a test area in the Klamath Basin for a cattle exclusion study to monitor water quality improvements.
 - (4) Selective Withdrawal/Intake Barrier at Iron Gate Dam: PacifiCorp assessed water flow, velocity, and bathymetry conditions around the intake to better understand the current conditions and inform future modifications to the intake barrier.
 - (5) Organic Matter Removal System at Link River/Keno Reservoir: Mechanical removal of algae biomass was tested in the A-canal behind the fish screen.
 PacifiCorp is planning to use study information to explore a larger scale pilot.
 - (6) Pilot study for nutrient reduction methods: PacifiCorp is evaluating the potential use of alum and other phosphorous sequestering additives as a means to improve water quality.
 - (7) Creation of TAC: The IMIC has been discussing creation of a TAC to provide input on the various pilot projects. Moving forward, the IMIC decided to use the existing Demonstration Wetland Facility TAC for pilot projects and add additional experts, as necessary, when discussing other pilot projects that may benefit from a TAC.

The next IMIC meeting is scheduled for January 15, 2014 in Yreka.

Delta Science Program Bay-Delta Science Review Workshops: As a follow-up to technical workshops held in the fall of 2012 on the comprehensive review of the Bay-Delta Plan (Phase 2), State Water Board staff is coordinating with the Delta Science Program (DSP) to organize two science reviews (workshops) on key areas of disagreement or uncertainty identified during the State Water Board's workshop process. The reviews will focus on (1) Delta outflows and non-flow related factors, and (2) interior Delta flows and non-flow related factors. The first workshop is scheduled to take place in February 2014. For each topic, a panel of independent scientists will review key technical background materials, hear presentations from experts on these issues and comments from the public, and will write a report responding to questions identified in the panel charge. A planning group consisting of representatives from non-governmental organizations, local Delta agencies, and state and federal water and fisheries agencies has been assisting with development of the charge for the workshops. The DSP lead scientist will have final authority over the charge and other planning aspects of the review. Upon completion, the reviews will inform the State Water Board's comprehensive review of the Bay-Delta Plan.

OFFICE OF DELTA WATERMASTER

Term 91 Fall Notice of Curtailment of Water Diversion in the Sacramento-San Joaquin Delta Watershed: On October 24, 2013, the Delta Watermaster mailed out a "Notice of Curtailment of Water Diversion" (Term 91 Notice) to 77 Delta diverters in the Sacramento-San Joaquin Delta (Delta) Watershed. The curtailment of diversions is ordered when: (1) the Delta is declared to be "in balance", and (2) stored water from the Central Valley Project and the State Water Project is released to meet water quality standards and other inbasin entitlements in the Sacramento-San Joaquin-Delta Watershed. The Notice of Curtailment advised the diverters that they will be curtailed from diverting water under their permits or licenses from October 30, 2013 through November 16, 2013 and required diverters to return Fall 2013 Compliance Certification Statements certifying whether they plan to use water during the curtailment period, and if so, indicating their alternate supply source, such as groundwater or contract (purchased) water. On November 15, 2013, the curtailment was extended until further notice.

Watermaster Enforcement Actions for Violations Regarding Water Use Reporting:

Water Right diverters are required to file annual and triennial use reports, pursuant to the conditions of their licenses, permits, and/or the Water Code. In January 2013, the State Water Board sent notification letters to water right licensees, permittees and statement holders to submit their 2012 annual and triennial use reports by July 1, 2013. In October 2013, the Delta Watermaster issued three Administrative Civil Liability Complaints against three diverters for failure to file a triennial use report and adopted two Cease and Desist Orders on October 17, 2013 for failure to file 2012 annual use reports. On November 20, 2013, the Delta Watermaster will issue two Administrative Civil Liability Complaints for violation of the October 17, 2013 final orders.

Settlement Agreement on Administrative Civil Liability Complaint for Failure to File Statements of Water Diversion and Use: On October 18, 2013, the Delta Watermaster issued an Administrative Civil Liability Complaint (ACL Complaint) to a diverter for failure to file Initial Statements of Water Diversion and Use reports for the diversion and use of water. The diverter reached an agreement with the Delta Water on October 24, 2013. On November 1, 2013, the Delta Watermaster issued a Decision approving a settlement agreement between the diverter and the Delta Watermaster on the ACL Complaint.

California Water Quality Monitoring Council

How Healthy are California's Estuaries? This is one of the many questions that the latest update to California's innovative My Water Quality website will answer. Developed by the California Estuary Monitoring Workgroup, the Estuaries Portal is a new tool that presents information on the health of California's estuaries, with an initial emphasis on the San Francisco Bay-Delta Estuary. Content regarding additional California's estuaries will be added in future portal updates. The goal is to provide timely information in an easy-to-understand manner for the public, environmental organizations, and water resource professionals. View the new California Estuaries Portal from the My Water Quality website, www.MyWaterQuality.ca.gov, under "Are Our Aquatic Ecosystems Healthy?" The My Water Quality website is now in its fourth year and is sponsored by the California Water Quality Monitoring Council, a partnership between Cal/EPA, the Natural Resources Agency, and numerous other federal, state, and local government and non-government organizations. The new California Estuaries Portal helps facilitate the dissemination of information generated through monitoring and research efforts to a variety of audiences, including the public, managers, and policy makers. Through portal development, the California Estuary Monitoring Workgroup is creating opportunities to make monitoring efforts more efficient, reduce redundancies, and improve coordination among member agencies and organizations.

MARINe Partnership Launches Tide Pool Portal:

- *"What is a tide pool?"*
- "What lives there and why are they important?"
- "How healthy are they?"

These are three of many questions addressed by a new California web portal developed and launched in October through collaboration between the Multi-Agency Rocky Intertidal Network (MARINe) and the California Water Quality Monitoring Council. The California Tide Pools Portal is a single-point, state-wide clearinghouse designed to make information readily available about rocky intertidal habitats, commonly known as "tide pools," to scientists, agency decision makers, and the public. View the portal at <u>www.MyWaterQuality.ca.gov</u> under the "Are Our Aquatic Ecosystems Healthy?" – Ocean tab.

Rocky intertidal zones, sometimes referred to as tide pools, are a diverse and unique ecosystem. Organisms living in tide pools are faced with naturally harsh conditions such as spending time out of water and strong wave action. In addition, tide pools are impacted by human activities, such overexploitation and trampling and are vulnerable to the effects of climate change. Long term monitoring of these sensitive coastal habitats helps us to better understand how tide pool plant and animal populations change over time and gives us information to help determine the condition of these ecosystems. MARINe is one of the largest partnership monitoring programs, which monitors over 100 different locations along the west coast of North America, a majority within California, using standardized procedures. MARINe is

a consortium of local, state, and federal government agencies, universities, and private groups charged with coordinating and carrying out the monitoring program. At some locations, monitoring has been active since the 1980s.

Desalination WQC Plan Amendments	On September 13, 2013, the Expert Review Panel (ERP) released a draft report on environmental effects of effluent diffusers and methodologies to address mitigation. The State Water Board held a workshop on September 23, 2013 to present the ERP findings and answer questions from the public. The ERP provided a final report on October 11, 2013. This final report incorporates the comments and questions from the September 23, 2013 workshop. Staff is in the process of completing the draft Staff Report/SED and anticipates public release of the amendments in Winter 2014 and a Board hearing in late Spring 2014.
Wetlands (Policy) WQC Plan Amendments	In April 2013, staff conducted focused stakeholder outreach. The objective of the outreach was to provide an overview and to receive feedback on the key issues of the draft policy amendments. Staff is in the process of completing the draft Staff Report/SED and anticipates a Board hearing in August 2014.
Small Domestic Wastewater General Order	The Draft Small Domestic Wastewater General Order has been provided to the Central Valley Clean Water Association for its input prior to public release. Staff anticipates taking the order to the Board for adoption in March 2014.
Utility Vaults Permit (Wastewater)	State Water Board staff has been meeting with seven utility companies to discuss the necessary revisions to the General National Pollutant Discharge Elimination System (NPDES) Permit for Discharges from Utility Vaults and Underground Structures to Surface Waters, Order 2006-0008-DWQ, NPDES No. CAG990002 (Utility Vaults Permit). The Utility Vaults Permit has expired and is being revised for reissuance. Staff anticipates releasing the draft revised permit for public comment in early 2014 and taking it to the State Water Board for consideration of adoption in Summer 2014.
Industrial General Permit (Storm Water)	State Water Board staff is reviewing public comments received during the public comment period for the Final Draft Industrial General Permit. Staff will consider the approximately 100 comment letters received in developing the draft permit. A Board hearing to consider the permit is scheduled for March 5, 2014.

Groundwater Ambient Monitoring and Assessment (GAMA)	State Water Board staff is working with the U.S. Geological Survey (USGS) to implement the GAMA Priority Basin Project. The target for this fiscal year is to sample 100 wells and publish five reports. So far this fiscal year from July 1, 2013 to October 31, 2013, the GAMA Program Priority Basin Project has sampled 16 wells under the triennial trends component and is currently sampling in the Madera-Kings study unit for the new Shallow Aquifer Assessment Study with 7 wells sampled as of October 31, 2013.
Program Well Testing	Between November 1, 2013 and June 30, 2014 staff estimates an additional 52 wells will be sampled for triennial and decadal trends, with the remaining 70 wells sampled to complete the Madera-Kings study unit. Five technical reports from the USGS for GAMA were published from July 1, 2013 to October 31, 2013 with an additional ten reports estimated to be published by the end of this fiscal year.

STATE WATER BOARD ILRP MONTHLY REPORT:

On October 1, 2013, ILRP staff met with CalRecycle staff to discuss draft In-vessel digestion regulations.

On October 10, 2013, ILRP staff participated in the California Roundtable for Agriculture and the Environment meeting.

On October 17, 2013, ILRP staff met with the Leafy Green Marketing Agreement Food Safety technical group to discuss the United Stated Department of Agriculture Food Safety Modernization Act.

On October 21, 2013, ILRP staff participated in a Farm Food Safety Conservation Network steering committee meeting to discuss proposed regulations implementing the federal Food Safety Modernization Act.

On October 22, 2013, ILRP staff participated in the Natural Resources Conservation Service (NRCS) State Technical Guide Committee meeting to review revisions made to several Best Management Practice (BMP) Standards. After reviewing and approving the BMP Standards, the committee had a lengthy discussion on how best to implement the Standards. The committee also discussed and reviewed a recent study titled "Long-term Fate of Nitrate Fertilizer in Agricultural Soils".

On October 23, 2013, ILRP staff met with California Department of Pesticides Regulation (DPR) staff to discuss a recent DPR study titled "Pesticide and Nitrate Trends in Domestic Wells where Pesticide Use is Regulated in Fresno and Tulare Counties."

On October 29 – 30, 2013, ILRP staff attended the California Department of Food and Agriculture Fertilizer Research Education Program (FREP) annual conference.

This month's Irrigated Lands Regulatory Program (ILRP) report covers the month of October 2013 and will provide an update on the activities of the North Coast, San Francisco, Central Coast, Los Angeles, Colorado River Basin, Santa Ana, and San Diego Regional Water Quality Control Board ILRPs.

NORTH COAST REGION AGRICULTURAL LANDS REGULATORY PROGRAM Update – October 2013

Water Quality Compliance Program for Discharges from Agricultural Lands

Update on Permit Development:

North Coast Regional Water Quality Control Board (Regional Water Board) staff has been developing the Agricultural Lands Discharge Program since 2011. Recently, Regional Water Board staff drafted a proposal to develop a series of targeted permits specific to agricultural commodities or geographic areas, as opposed to a single general permit for all of the North Coast Region.

In the near term, Regional Water Board staff will focus efforts on developing either Waste Discharge Requirements (WDRs) or conditional waivers of WDRs for each of the following commodities/areas: vineyards and orchards, agriculture in the Tule Lake watershed, and outdoor lily bulb cultivation. Regional Water Board staff will continue to implement the Scott and Shasta River TMDL Conditional Waiver of WDRs, and participate in the development of the statewide Grazing Regulatory Action Plan. Regional Water Board staff will continue to address discharges from marijuana cultivation through education, compliant response, and enforcement, but is also developing regulatory options for the Board's consideration. Finally, Regional Water Board staff is proposing to study groundwater and surface water quality in Butte Valley to help assess the risk from agricultural discharges.

Regional Water Board staff presented the proposal to the Stakeholder Advisory Group, which Regional Water Board staff has been working with to develop the program, at a September 10, 2013, Advisory Group meeting. The majority of the Stakeholder Advisory Group was in support of the proposal, with some concerns. Regional Water Board staff presented the proposal and feedback to the North Coast Regional Water Board on September 26, 2013. The Regional Water Board gave staff direction to move ahead to implement the proposal. Regional Water Board staff is now working on project plans for developing the three separate permits noted above.

SAN FRANCISCO BAY REGION AGRICULTURAL REGULATORY PROGRAM Update – October 2013

The San Francisco Regional Water Board (Regional Water Board) is working on:

- a) Developing a general waste discharge requirements (WDRs) Order for vineyard operations in the Napa River and Sonoma Creek watersheds;
- b) Renewal of a conditional waiver of WDRs for grazing operations in the Tomales Bay watershed (Tentative Order); and
- c) Renewal of a paired conditional waiver of WDRs Order and general WDRs Order for confined animal facilities.

Progress on the Vineyard Order continues. The Regional Water Board has continued to coordinate with the North Coast Regional Water Quality Control Board agricultural program and maintain momentum on fostering additional third-party technical assistance capacity in both watersheds. The Regional Water Board has backfilled a key staff position and expects to restart working on the vineyard WDRs and related CEQA documentation in mid-November 2013.

The Tomales Bay Tentative Order was released for a 30-day public comment period on September 16, 2013. Prior to its release, Regional Water Board staff attended a Marin Farm Bureau meeting to introduce the Tentative Order and explain key differences between it and the 2008 Conditional Grazing Waiver that it renews. During the comment period, Regional Water Board staff conducted additional outreach by attending an October 2, 2013 Animal Committee meeting in Petaluma and by hosting a public workshop on October 10, 2013, at the Marconi Center in Marshall. At each meeting, Regional Water Board staff explained that the requirements of the Tentative Order remain unchanged as compared to the 2008 Grazing Waiver, with the exception of a new requirement for the measurement and reporting of residual dry matter. Regional Water Board staff is reviewing comments received and anticipates bringing the Tentative Order before our Board for their consideration later this fall.

The Regional Water Board is working to renew its waiver of WDRs and general WDRs for confined animal facilities. The proposed Orders fundamentally maintain previous permit requirements, yet include additional requirements for grazing pastures associated with confined facility operations, drinking water well testing, and adjusted fees. The Tentative Orders further clarify the scope of the permits to make clear that they apply to various types of confined animal facilities (e.g., horse facilities), not just cow dairies. Similar to the Tomales Bay Grazing Tentative Order, Regional Water Board staff is engaging in stakeholder outreach efforts prior to, and overlapping with, the public release of the draft, which is anticipated for November 2013.

CENTRAL COAST REGION IRRIGATED LANDS REGULATORY PROGRAM Update – October 30, 2013

STATUS OF IMPLEMENTATION OF THE AGRICULTURAL ORDER

On September 24, 2013, the State Water Resources Control Board (State Water Board) issued Water Quality Order 2013-0101 (State Order) for the Central Coast region, which requires farmers or coalitions of farmers to prioritize drinking water sampling and assessment for nitrate and notify well users if those nitrate levels exceed public health standards for drinking water, and further requires some farmers to report the amount of nitrogen they apply to crops.

The State Order resolves all of the petitions filed by environmental and agricultural interests seeking review of the Agricultural Order. The State Water Board allowed four written public comment periods and conducted three public meetings on proposed draft orders prior to adopting the State Order.

The State Order supports in large part, but modifies the Central Coast Regional Water Quality Control Board's (Regional Water Board) Conditional Waiver of Waste Discharge Requirements and Monitoring and Reporting Programs for Discharges from Irrigated Lands ("Central Coast Agricultural Order"), Central Coast Water Board Orders No. R3-2012-0011, R3-2012-0011-01 R3-2012-0011-02, and R3-2012-0011-03).

The Regional Water Board's Agricultural Order, with revisions directed by the State Order, will provide enhanced implementation and monitoring of agricultural management practices and monitoring of water quality. The State Order also directs an expert panel to be convened to provide a more thorough analysis and long-term statewide recommendations regarding many of the issues implicated in the Agricultural Order, especially requirements related to nutrient management practices and nitrogen reporting.

The Regional Water Board is implementing the Agricultural Order, as modified by the State Order. One such modification is the revision of the Annual Compliance Form, which became available to Central Coast growers on October 22, 2013. The Regional Water Board Irrigated Lands Regulatory Program staff is implementing additional changes in response to the State Order and will provide an update to the Central Coast Water Board at its December 2013 Board Meeting.

LOS ANGELES REGION CONDITIONAL WAIVER FOR IRRIGATED LANDS STAFF UPDATE TO THE SWRCB Update – October 30, 2013

Compliance with the Renewed Conditional Waiver

The Nursery Growers Association Los Angeles County Irrigated Lands Group (NGA-ILG) and the Ventura County Agriculture Irrigated Lands Group (VCAILG) are the two discharger groups in the Los Angeles Region that have formed to comply with the Conditional Waiver. To comply with the Conditional Waiver, these groups must submit Water Quality Management Plans (WQMPs) to reduce pollutants discharged from their members' growing operations. VCAILG submitted their 2012 WQMP in March 2013. Los Angeles Regional Water Control Board (Regional Water Board) staff provided lengthy comments on the WQMP in July 2013 and VCAILG is currently revising the WQMP in response to comments. NGA-ILG submitted their 2013 WQMP on July 26, 2013. Regional Board staff is currently reviewing the document. These WQMPs are crucial to effective BMP implementation and Regional Water Board staff is working closely with VCAILG and NGA-ILG to ensure that the WQMPs will result in water quality improvement.

Enrollment

Regional Water Board staff sent out Notices to Enroll on August 29, 2013, to 69 growers in Ventura County who did not pay annual fees to VCAILG, and Notices of Violation to 12 growers in Ventura County on October 17, 2013, who did not respond to the Notices to Enroll. As a result, several growers have contacted Regional Water Board staff to confirm that they will be enrolling in the Conditional Waiver. Regional Water Board staff will continue to conduct enforcement, as necessary.

Regional Water Board staff is currently involved in talks with the Los Angeles Department of Water and Power (DWP) and Southern California Edison (SCE) to enroll the nursery growers leasing DWP and SCE property. On September 24, 2013, staff from DWP and the Regional Water Board met to discuss the results of a letter that will be sent to DWP tenants in November 2013. The letter will give growers information about the Conditional Waiver and the Regional Water Board, and also inform tenants that their lease could be at risk if they do not enroll in the Conditional Waiver program. On September 11, 2013, SCE sent out a packet to all their tenants that included information about the Conditional Waiver, an enrollment form for NGA-ILG, and a letter stating if tenants do not enroll in the Conditional Waiver program in 45 days their lease could be terminated. Once SCE and NGA-ILG have processed all the information from growers in response to this letter, Regional Water Board staff will meet with both parties to discuss the results from this effort and decide what the next steps will be to enroll growers.

GIS Database

Regional Water Board staff has been creating a geographically referenced database of data relevant to the Irrigated Lands Program in Region 4. Data includes water quality monitoring results and mailing addresses of Conditional Waiver program members and growers that are targeted for outreach/enforcement actions. This database is consistently being updated as Regional Water Board staff receives more information on enrollment and BMP implementation. Regional Water Board staff also recently received GIS data from the Los Angeles County Agricultural Commissioner. This file contains the locations of all known agricultural operations within Los Angeles County, and includes basic information of the types of crops in production. Regional Water Board staff will use this data to locate irrigated agricultural operations that are not currently enrolled in the Waiver program. The Ventura County Assessor's office also recently sent updated parcel data with assessor parcel numbers to assist Regional Water Board staff in updating the VCAILG membership database.

Education Workshops and Outreach

VCAILG provided three classes during September 2013. One of the classes is being offered online to allow growers flexibility in attaining their eight required hours of education. The class takes approximately two hours to complete and has a quiz at the end to ensure that participants have absorbed the material. NGA-ILG provided two classes in September 2013 and also supported the California Nursery Conference on October 7, 2013, which provided some education credit to the growers who attended. Since renewal of the Conditional Waiver, both VCAILG and NGA-ILG have provided numerous opportunities for their members to receive all eight hours of education credit required by the Conditional Waiver.

Grant Management

Regional Water Board staff is overseeing a Proposition 84 grant for a mobile irrigation laboratory to improve irrigation efficiency on farms in Ventura County (Grant Agreement No. 10-417-554). The grantee is the Ventura County Resource Conservation District (RCD). Under the grant, RCD staff travels to farms, evaluates irrigation efficiency, recommends improvements, and provides cost share funding to implement the recommended improvements. The goal of the grant is to reduce dry-weather loading of agriculture-related pollutants. Regional Water Board staff reviews invoices and attends regular technical advisory committee meetings, including a meeting in September 2013, as part of their oversight of this grant.

Regional Water Board staff continues to manage a Clean Water Act section 319(h) grant which was executed for the purpose of identifying the contribution of and reducing metal loadings from nurseries and other irrigated agricultural lands in the San Gabriel River Watershed (Grant Agreement No. 11-098-554). The grantee is the Council for Watershed Health (CWH). The CWH has reported the status of their project in bi-monthly meetings with Regional Water Board staff and other stakeholders, and has identified priority locations for BMP implementation along the San Gabriel River. The drought has negatively affected the project, however, preventing collection of baseline copper data imperative to assess the effectiveness of implemented BMPs. CWH recently requested an extension of one year to wait for rain to create sufficient runoff to collect samples. The request was approved on August 23, 2013.

COLORADO RIVER BASIN CONDITIONAL WAIVER FOR AGRICULTURAL DISCHARGES Updated - October 25, 2013

Colorado River Basin Regional Water Board (Regional Water Board) staff is implementing Board Order R7-2012-0047, a Conditional Waiver of Waste Discharge Requirements (WDRs) for agricultural wastewater discharges and discharges of wastes from drain operation and maintenance activities within the Palo Verde Valley in Riverside and Imperial Counties. In October 2013, Palo Verde Irrigation District (PVID) submitted its Coalition Group's membership of growers farming over six acres. The enrollment of irrigated lands covered 93,000 acres and over 99% of the farms. A Quality Assurance Project Plan submitted by PVID in compliance with the Conditional Waiver was approved on October 25, 2013. The water quality monitoring and reporting program will begin this winter.

Board Order R7-2013-0002 for the Bard Unit of Reservation Division (Imperial County) Conditional Waiver was adopted on January 17, 2013. This Conditional Waiver affects about 7,000 acres of farmland along the Colorado River near Yuma, Arizona. Implementation will not begin until 2014 though staff continues to coordinate with the Bard Water District representatives on the formation of a local coalition group. Staff is actively working with interested parties in the Coachella Valley to develop a Conditional Waiver of WDRs for consideration for adoption in early 2014. This Conditional Waiver affects about 60,000 acres of farmland in central Riverside County north of the Salton Sea. Regional Water Board staff is preparing the environmental documents to be prepared pursuant to CEQA and the draft conditional waiver. In September 2013, Regional Water Board staff received notification of the incorporation of the Coachella Valley Irrigated Lands Coalition group. Riverside County Farm Bureau and Coachella Valley Water District assisted the formation of this coalition group, and through a Memorandum of Understanding, are providing funding for start-up costs.

Regional Water Board staff is also coordinating with interested parties in the Imperial Valley (over 450,000 acres of irrigated lands) to develop a Conditional Waiver of WDRs for consideration for adoption in 2014.

Grant Management

Regional Water Board staff is overseeing a \$900,000 Proposition 50/84 Agricultural Water Quality Grant Program project (Grant Agreement 09-351-557) titled the Precision Drain Cleaning BMP Plan. The grantee is the Imperial Irrigation District. The goal of the grant project is to reduce impacts of IID's dredging and maintenance operations throughout the over 1,300 mile drainage system by implementing a drain improvement program.

Under the grant, IID staff will:

- Develop a protocol to classify, prioritize, and rectify substandard earthen drainage segments,
- Implement drain improvements as determined necessary,
- Implement a program to utilize vegetation (i.e., salt grass) as a drain erosion inhibitor, and
- Implement a GPS-guided drain cleaning program.

Regional Water Board staff is also managing a \$340,000 Clean Water Act section 319(h) grant which was executed for the purpose of completing the construction of treatment wetlands for diverted flow from the Alamo River in Imperial County where suspended solids, nitrogen, phosphate, and fecal coliform originating from agricultural lands will be removed through organic activities prior to being released back to the Alamo River on its journey to the Salton Sea (Grant Agreement 12-411-257). The grantee is Desert Wildlife Unlimited.

SANTA ANA REGION CONDITIONAL WAIVER OF WASTE DISCHARGE REQUIREMENTS FOR AGRICULTURAL DISCHARGES (CWAD PROGRAM) Update – October 30, 2013

Santa Ana Regional Water Quality Control Board (Regional Water Board) staff is proposing that all operators of irrigated lands over 20 acres enroll in a conditional waiver of waste discharge requirements. Regional Water Board staff is calling their agricultural regulatory program the Conditional Waiver (of waste discharge requirements) for Agricultural Discharges (CWAD).

Regional Water Board staff has developed a "CWAD Program Advisory Group" which consists of about 20 members including agricultural farmers, local growers, industry groups, NGOs, and major stake-holders. The last CWAD advisory group meeting was held on Thursday, July 25, 2013. The following were the major topics of discussion during the meeting:

- 1. CWAD Program status and revised CWAD Program schedule;
- Eastern Municipal Water District's (EMWD) Data, which was sent to the Regional Board by the EMWD;
- 3. Setting up and streamlining administrative processes for the CWAD Program (Western Riverside County Ag. Coalition (WRCAC);
- 4. CWAD Program cost estimates and CWAD Notice of Intent (NOI);
- 5. Internal draft agricultural conditional waiver, staff report, and draft CEQA Negative Declaration; and
- 6. Other related issues/discussions.

Regional Water Board staff has been regularly attending Western Riverside County Agricultural Coalition (WRCAC) monthly technical committee meeting. WRCAC is a major stakeholder in the CWAD program. Regional Water Board staff has been coordinating with the WRCAC to identify proposed CWAD program sampling station locations in the San Jacinto River Watershed area where this program is being developed and will be implemented.

Next scheduled CWAD advisory group meeting is scheduled for November 7, 2013, at 10:00 a.m. at the Riverside County Farm Bureau Office, located in Moreno Valley, CA.

SAN DIEGO WATER BOARD IRRIGATED LANDS REGULATORY PROGRAM (AG WAIVER) Updated – October 2013

San Diego Regional Water Quality Control Board (Regional Water Board) staff continues to progress on several fronts related to our current Conditional Waiver of Waste Discharge Requirements for Discharges from Agricultural and Nursery Operations (Ag Waiver).¹ Our general tasks currently include: conducting inspections at randomly selected facilities to assess the level of Discharger familiarity with the Ag Waiver conditions; developing the informal enforcement processes for documented noncompliance; and working through processes associated with renewing the Ag Waiver in 2014.

Activities in the San Diego Region include:

- Regional Water Board staff is working through an additional list of 135 agricultural operations that have reportedly left the existing agricultural monitoring groups/coalitions, and failed to file an individual notice of intent (NOI) for coverage under the Ag Waiver. The identified operations are being investigated by the Compliance and Enforcement Assurance Unit to evaluate enforcement alternatives and prioritize further actions according to available resources.
- 2. Regional Water Board staff continue to research and develop a list of potential agricultural operations that may be classified as "non-filers" (e.g., failed to enroll in a monitoring group or file a notice of intent (NOI) to enroll as an individual operation).
- 3. Regional Water Board staff had teleconferences and attended meetings with Rainbow Municipal Water District (RMWD) Board member Griffiths to discuss RMWD Board's desire to form a monitoring group.
- 4. Regional Water Board staff sent out over 100 letters to notify agricultural operators, who are eligible for enrollment or enrolled in the Ag Waiver, of our intent to conduct site visits/inspections during the week of September 20 through 27, 2013. Although there were a couple of mis-communications with dischargers during the period while our office phone system was off-line, staff successfully scheduled and completed 46 inspections/site visits at agricultural operations between September 18 and October 1, 2013.
- 5. Regional Water Board staff continues to develop draft revisions to the Ag Waiver, draft Monitoring and Reporting requirements, and associated CEQA documents for regional management review and comment prior to release for public review.
- 6. On October 9, 2013, Regional Water Board staff sent out 255 letters to members of Rainbow Municipal Water District Monitoring Group (RMWDMG) to notify them that RMWDMG is not recognized by the San Diego Water Board as a monitoring group. San Diego Water Board further advised these members that in order to comply with our Ag Waiver they may form or join a new approved monitoring group or submit a complete NOI for coverage as an individual discharger.
