# **Board Member Moore:**

> The Central Coast Water Board updated their post construction requirements in July to align with a State Water Board order that was adopted in February for Phase II municipal separate storm sewer systems. It was nice to see a detailed discussion from the Central Coast Water Board about where things are headed and what we'll learn from their process. It's good to know there is coordination between the State and Regional Water Boards.

> This month the North Coast Water Board is going to take up an interesting policy on nutrients on August 22<sup>nd</sup>. It is similar to what the Lahontan Water Board is doing to implement the Lake Tahoe Total Maximum Daily Load. They'll look at nutrients and identify limits on the point sources and any opportunities available. There was a grant obtained through the U.S.D.A. by the local Resource Conservation District as well as the City of Santa Rosa to explore innovative approaches to reducing nutrients from nonpoint sources.

### **Board Member Doduc:**

- > At one of the Central Valley Water Board meetings they discussed one of the mandatory minimum penalty (MMP) items for over three hours. Member Doduc is strongly supportive of the due process and public participation effort even though during these discussions there is little room for discretion. She would like to know if there is a more efficient way to look at these MMP issues. She has requested a summary from Director of the Office of Enforcement, Cris Carrigan, on what we have learned from these MMP proceedings, any success stories, and costs in resources and time.
- > The Central Valley Water Board also brought up the issue of petitions, especially petitions that are filed to the State Water Board and just sit there. The particular item discussed was a proposed administrative civil liability (ACL) for a dairy operator who petitioned the underlying requirements to the State Water Board. Member Doduc would like to see an improved petition handling process and the way we communicate with petitioners. She encourages staff to move as quickly as possible to get the proposed, revised regulations, described by Chief Counsel Michael Lauffer, out for public comment.

## Board Member D'Adamo:

Last week went on a tour of the Metropolitan Water District where the purpose was to pull together officials from Northern California agricultural water districts. The goal of the tour was to develop relationships with some key board members from Sacramento Valley and San Joaquin Valley along with Metropolitan Water District board members. The idea was to develop stronger relationships so transfers and flow releases could take place. This would help to increase comfort levels with various stakeholders. It was also an opportunity to develop some common ground with the agricultural water districts in the north.
