# SUBJECT: Conditional Waiver of Waste Discharge Requirements for Discharges from Irrigated Lands

## SUMMARY

This Second Supplemental Sheet includes four attachments. Attachment 2 and Attachment 5 were mentioned in the Supplemental mailing sent out on July 2, 2004. Two additional attachments are related to information received on July 2, 2004. Attachment 2 includes additional information on the proposed cooperative monitoring program and Attachment 5 is revised Waiver Order R3-2004-0117 in strikeout version, containing a revised time schedule for implementing the cooperative monitoring program. Attachment 7 is revised Monitoring and Reporting Program R3-2004-0117, in strikeout version. Attachment 8 is a letter from agricultural industry groups containing a monitoring proposal, revised from their March 19, 2004 submittal to the Board. This attachment also includes staff's response.

## DISCUSSION

**Supplemental Attachment 2** contains additional clarification on the cooperative monitoring program and discussion of a possible approach to phasing in the program. This approach is being proposed in consideration of the high level of concern expressed by the agricultural industry about the time needed to establish a cost allocation formula to equitably distribute costs and a desire for an opportunity for review of the cooperative program after initial implementation.

**Supplemental Attachment 5** is revised Waiver Order R3-2004-0117 in strikeout version, containing a revised time schedule for implementing the cooperative monitoring program. The time schedule has been revised after review of the agricultural industry's monitoring proposal. Commencement of monitoring in two areas is proposed to start up nine months earlier than Regional Board staff originally proposed, while the date for full regionwide monitoring has been moved back three months, to allow sufficient time for the cooperative program to develop a cost allocation structure. Additional tasks and milestones are also included.

**Supplemental Attachment 7** is revised Monitoring and Reporting Program R3-2004-0117 in strikeout version. Listing of tasks and due dates has been removed for clarity and consistency, since all mandatory tasks and due dates are contained in Waiver Order R3-2004-0117. Clarifying language has been added regarding toxicity testing.

Supplemental **Attachment 8** is the Agricultural Industry's Revised Monitoring Proposal, received July 2, 2004 and resubmitted with editorial changes dated July 6, 2004, along with Staff's response. The proposal was revised from the one previously submitted to the Board on March 19, 2004 (staff response to the original letter was included both in the response to comments in the Board agenda packet, Attachment 6, and in our more detailed June 22, 2004 letter, mailed to the Board on July 2, 2004).
