Beginning today, Monday, Assemblyman Blakesley will be sponsoring negotiations between the CSD (Schicker and Fouche) and the water board, as announced on the news today. We must keep up the pressure that we want no compromises. Supporters of the new LOCSD wrote Measure B in a way that would keep a sewer plant from being built. Now the "Gang of Five" is claiming that it is law, although it was struck down. To fortify their position, they have engineered a delay of the appeal (to December), thus insuring that they will look like they are "forced" into the stoppage. Now their ex-lawyer Briggs has announced she will sue the LOCSD (based on Measure B) if they resume the project. THIS ENTIRE SETUP WAS PLANNED FROM THE GET-GO.
