Subject: Phase II Monterey Regional SWMP public notice

To Interested Parties:

A Storm Water Management Program (SWMP) to comply with the General Permit for the Discharge of Storm Water from Small Municipal Separate Storm Sewer Systems (Small MS4 Permit) was submitted by the Monterey City and County and other permittees. The SWMP describes the program to be implemented in the Monterey region.

The SWMP has been reviewed by Regional Water Quality Control Board (Regional Water Board) staff and is anticipated to meet the Maximum Extent Practicable (MEP) standard. The SWMP will be available for public review on the State Water Resources Control Board's (State Water Board) website at http://www.waterboards.ca.gov/stormwtr/sm_municipal_swmp.html. It will remain there for at least 30 days, during which, a member of the public can request a public hearing by the Regional Water Board. Request for public hearings must be made in writing to the appropriate Regional Water Board and be received in that office by 5:00 p.m. on December 16, 2005 and must contain a summary of the reason or reasons the hearing is being requested.

If there are no requests for a public hearing, the permit coverage under the Small MS4 Permit for Monterey, et al. will commence on December 17, 2005.
