SUMMARY

On December 11, 2007, the Assistant Executive Officer, on behalf of the Central Coast Water Board's enforcement staff, issued Administrative Civil Liability Complaint No. R3-2007-0101 (Complaint) to Pacifico Azul (Discharger), owned and/or operated by Ms. The Complaint alleged that the Discharger violated the Irrigated Rebecca Bozarth. Agriculture Order by failing to submit a report of waste discharge or notice of intent to comply with the Order. The Complaint recommended that the Water Board assess civil liability in the amount of \$9,136 against the Discharger. Attached to this report are documents submitted to the advisory staff by the enforcement staff, including an enforcement staff report and their brief with attachments; Discharger's comments, arguments, and evidence (if submitted in time); and a draft Administrative Civil Liability Order. At the hearing the Water Board will consider whether to adopt an Administrative Civil Liability Order and may increase or decrease the amount or decline to adopt the Order. The advisory staff will present its evaluation and recommendation at the hearing.

Note that this item is an adjudicatory proceeding subject to separation of functions of Water Roger Briggs, Executive Officer, and Frances McChesney, Senior Staff Counsel, are on the Advisory Staff. Michael Thomas, Assistance Executive Officer. Harvey Packard, Todd Stanley, and Yvonne West are on the Enforcement Staff. The Enforcement Staff and Pacifico Azul are parties to this matter. Communications between the Advisory Staff or Water Board members and the parties to this matter are prohibited unless they involve matters of procedure or practice not in controversy.
