NOTICE IS HEREBY GIVEN that the Central Coast Regional Water Quality Control Board (Central Coast Water Board) will consider an amendment to the Water Quality Control Plan for the Central Coastal Basin (Basin Plan) during a public hearing on **July 30-31, 2015**. Specifically, the Central Coast Water Board will consider a Basin Plan amendment to:

Incorporate Total Maximum Daily Loads for Nitrogen Compounds and Orthophosphate in Streams of the Pajaro River Basin

At the conclusion of the hearing the Central Coast Water Board will consider approval of the proposed resolution. If accepted, the resolution will amend the Basin Plan by incorporating Total Maximum Daily Loads (TMDLs) for nitrogen compounds and orthophosphate in streams of the Pajaro River Basin.

Actions to amend the Basin Plan by the Central Coast Water Board will be taken in accordance with a regulatory program exempt under section 21080.5 of the Public Resources Code from the requirement to prepare an environmental impact report under the California

Environmental Quality Act (Public Resources Code, section 21000 et seq.) and with other applicable laws and regulations.

The Central Coast Water Board separately transmitted a notice of an opportunity for public comment previously on March 11, 2015. The public comment period and ended on April 24, 2015. Therefore, Central Coast Water Board staff is not accepting further written comments at this time. Oral comments may be provided to the Central Coast Water Board at the public hearing shown above. Time limits may be imposed on oral presentations at the hearing. At the conclusion of the public hearing, the Central Coast Water Board will consider approval of the proposed Basin Plan amendment. The Central Coast Water Board may close the public hearing and the comment period, but consider adoption of the amendments at a later public hearing.
