- February 14, 2024, spoke with Angela Schroeter of the Water Board regarding today's environmental justice and racial equity item. Member Hunter is the liaison to the board for environmental justice.

#### **Vice Chair Wolff:**

- December 15, 2023: Hosted end-of-the-year festivities with current and former staff.
- January 11-12, 2024, attended the Morro Bay Bird Festival; Vice Chair Wolff provided tours and presentations on vineyard sustainability, emphasizing water conservation.
- January 26, 2024, participated with the Coastal San Luis Resource Conservation
  District and gave a tour to Senator Laird and his staff of the Tally Ho Creek flood
  management and site upgrades. Senator Laird had visited a year ago and came
  back to see the progress made by the California Conservation Corps and the
  RCD.

- February 13, 2024, attended the Community Advisory Group meeting of the airport parties. Vice Chair Wolff indicated the progress was encouraging and was glad he attended.
- Vice Chair Wolff wanted to share his recent Zoom meeting with a Belgian company, BeeODiversity. They use bees as drones to collect pollen and track pesticides, types of pesticides, application locations, and the type of crops or wild plants pollinated by the bees.

5. Report by State Water Resources Control Board Liaison [Sean Maguire, 916/341-5877, Sean.Maguire@waterboards.ca.gov]

The report by the State Water Resources Control Board liaison, Sean Maguire, focused on several key areas. Sean Maguire highlighted the retirement of the executive director, Eileen Sobeck, and the appointment of Eric Oppenheimer as the

new executive director. Sean Maguire also discussed the adoption of direct potable reuse regulations, emphasizing the challenges associated with implementing such projects, including funding and community support. Sean Maguire touched on the complexity of operating these facilities and the blurring lines between wastewater and drinking water treatment. Additionally, Sean Maguire mentioned the State Water Board's strategic work plan and the many tasks ahead, both at the state and regional levels.

#### **Enforcement**

 Consideration of Adoption of an Administrative Civil Liability Order for JSM Organics, Inc., Monterey County, Administrative Civil Liability Complaint No. R3-2023-0050 [Harvey Packard, Supervising Water Resource Control Engineer, 805/542-4639, Harvey.Packard@waterboards.ca.gov]

Chair Gray introduced the item and explained the process for the hearing. Board members and staff confirmed they had no ex-parte communications before the hearing. All persons who were to provide testimony were sworn in, including Javier Zamora of JSM Organics, Inc. and Thea Tryon, Mary Hamilton, Tamara Anderson, and Paula Richter of the Central Coast Water Board's Prosecution Team, and Katya Smirnova of IEc, the Prosecution Team's expert witness.

The Prosecution Team began their case presentation with an introduction by Thea Tryon. Paula Richter and Tamara Anderson provided evidence, argument, and other information relevant to the case. The Prosecution Team's counsel, Julie Macedo, discussed how the Prosecution Team used the penalty methodology in the State Water Board's 2017 Enforcement Policy to arrive at their recommended liability amount. Thea Tryon concluded the Prosecution Team's presentation with their recommendation, which was a penalty amount of \$67,010.

The Advisory Team's counsel, Sophie Froelich, asked several questions of the Prosecution Team concerning, among other things, whether proper notice had been given to JSM Organics about additional days of violation and the appropriateness of disclosing potentially confidential communications. Julie Macedo provided responses.

Javier Zamora presented his case, explaining how he came to own the property, his belief that each tenant farmer needed to file their own total nitrogen applied reports, his reduced 2023 earnings due to storm damage, and his position that the proposed penalty was excessive.

The Board had several questions for Javier Zamora, including why he didn't respond to Irrigated Lands Program staff's and Prosecution Team's reminder emails and notices of violation.

After questions and closing statements, the Board met in closed session to deliberate. After reconvening in open session, Sophie Froelich announced that the Board had deliberated and reached a conclusion and stated the Board's intention to order liability in the amount of \$56,840. Sophie Froelich and the Board then went over the findings in the Board's Order with Javier Zamora and the public.

Member Hunter moved that the Board approve a liability amount of \$56,840 and have the Executive Officer issue an order.

After this motion passed, Sophie Froelich suggested that, to ensure the Order would not be issued until after typographical errors and citations to evidence were added, that (a) alternative approval language to be incorporated into the Order; and (b) that the Board rescind its previous vote; and (c) move to approve the alternative language and delegate authority to the Executive Officer to issue the Order consistent with the civil liability amount of \$56,840 and findings presented at the hearing, with certain revisions to add citations and make editorial changes.

Member Rodriguez moved to rescind the Board's earlier approval.

Member Rodriguez then offered the following motion:

That the Board delegate its authority to the Executive Officer to issue Order R3-2024-0025, consistent with the findings presented at the hearing following closed session, for liability in the amount of \$56,840, that it is the Board's intent to allow Javier Zamora 30 days to file a petition from the time that Executive Officer Ryan Lodge signs the order, and that a new finding be added to the order, as follows:

At the hearing held on February 15, 2024, the Central Coast Regional Water Quality Control Board also delegated authority to the Executive Officer to issue Administrative Civil Liability Order R3-2024-0025 consistent with the civil liability amount and findings presented by the Advisory Team and the Board at the hearing, with certain revisions to add citations and make other editorial corrections. The issuance by the Executive Officer of Administrative Civil Liability Order R3-2024-0025 will constitute the final action of the Board pursuant to Water Code section 13320.
