## Challenges and Solutions: The Intersection of Water Quality and People Experiencing Homelessness on the Central Coast

You are invited to participate in a solution focused collaborative forum with elected officials, local and state agencies, and non-profit entities to identify and promote actions that reduce homelessness, as well as associated water quality impacts and risks to human health. Actions such as improving access to shelters, affordable housing, social services, clean drinking water, and sanitation services can reduce impacts to central coast waterways. The workshop includes panelists with diverse knowledge and experience in: 1) the scope and magnitude of the impacts to water quality and public health that result when people do not have access to shelter, clean water, and sanitary services; 2) innovative approaches taken by municipalities and non-governmental organizations to address these challenges; and 3) opportunities to collaborate and leverage funding mechanisms to improve access to shelters, affordable housing, social services, clean drinking water, and sanitation services for people experiencing homelessness.
