BACKGROUND

On September 20, 2023, the State Water Board adopted Order WQ 2023-0081,3 In the Matter of Review of General Waste Discharge Requirements for Discharges from Irrigated Lands Order R3-2021-0040 (Remand Order). The Remand Order directs the Central Coast Water Board to develop an alternative water supply program for residents in the Central Coast region relying on groundwater in areas where the maximum

contaminant level (MCL) for nitrate is exceeded as a result of agricultural operations. The Central Coast Water Board is seeking public input on the development of this program and encourages the public to submit written comments on the publicly available documents and/or to participate in the workshop.
