**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; LENNAR HOMES OF
CALIFORNIA, INC. CARSON CREEK UNIT 2 PROJECT (WDID#5A09CR00161A2),
EL DORADO COUNTY**

This Order responds to the 13 April 2022 request for an amendment of the Carson Creek Unit 2 Project (Project) Section 401 Water Quality Certification (WDID#5A09CR00161A1). The original Water Quality Certification (Certification) was issued on 13 April 2017. The Certification was amended on 6 April 2022 (WDID#5A09CR00161A1). The requested second amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Lennar Homes of California, Inc., is requesting a time extension through 31 May 2027. A time extension was authorized by the United States Army Corps of Engineers on 9 February 2022.

Lennar Homes of California, Inc. has provided documentation from the United States Army Corps of Engineers (SPK-1992-00105) authorizing in-water construction activities to continue until 31 May 2027.

The Certification is amended as shown below:

Approved Dates of Project Implementation: 09 February 2022 to 31 May 2027.

ADDITIONAL CONDITIONS:

The applicant is responsible for submitting a request to extend the Lake or Streambed Alteration Agreement to CDFW prior to the expiration of the agreement on 30 May 2022.

No fee was required for this amendment. Total fees of \$90,000.00 for the original Certification were received on 15 November 2016. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as Category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
