ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; GLENN COUNTY PUBLIC WORKS AGENCY, WALKER CREEK BRIDGE (11C-0267) REPLACEMENT PROJECT (WDID NO. 5A11CR00045A1), GLENN COUNTY

This Order responds to the 6 January 2025 request for an amendment to the Glenn County Public Works Agency, Walker Creek Bridge (11C-0267) Replacement Project Section 401 Water Quality Certification (WDID No. 5A11CR00045). The original Water Quality Certification was issued on 5 May 2020. The requested amendment is hereby approved, and the original Certification is therefore amended as described below. AMENDMENT:

Glenn County Public Works Agency (hereinafter Permittee) is requesting an amendment to the Section 401 Water Quality Certification and Order to extend the original expiration date of 5 May 2025 to align with the United States Army Corps of Engineers' (SPK-2020-00147) expiration date of 14 March 2026, when the existing Nationwide Permits are scheduled to be modified, reissued, or revoked. The request has been approved, and the expiration date of the Section 401 Water Quality Certification is **extended to 14 March 2026**.
