### **NOTICE OF APPLICABILITY; GENERAL SECTION 401 WATER QUALITY CERTIFICATION ORDER REQUIREMENTS FOR THE ST. SUPERY ESTATE VINEYARDS & WINERY, DOLLARHIDE ROAD. MAXWELL CREEK PARCEL D1A EROSION PROJECT (WDID#5A28CR00051), NAPA COUNTY**

On 10 February 2025, St. Supery Vineyards & Winery (Applicant) filed a notification requesting coverage under the 20 September 2024 State Water Resources Control Board Clean Water Act Section 401 General Water Quality Certification of the United States Army Corps of Engineers (USACE) Regional General Permit 5 (WQ 2024-0085-DWQ) (General Certification Order) for the Dollarhide Road Maxwell Creek Parcel D1A Erosion Project (Project). After review of the notification and the supplemental material submitted by the Applicant, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) has determined that the Project qualifies for enrollment under this General Certification Order. The proposed activity will take place in 9.3 cubic yards of waters of the United States.

The Central Valley Water Board is certifying this Project under United States Army Corps of Engineers Regional General Permit 5, Emergency Repair and Protection Activities, subject to the conditions and the notification requirements described in the Nationwide Permit ("Special Conditions"). This Notice of Applicability is being issued under the General Certification Order pursuant to Section 3838 of the California Code of Regulations.

under the General Certification Order is no longer valid if the Project (as described) is modified.

**PROJECT DESCRIPTION:**

The 9.3-cubic yard Dollarhide Road Maxwell Creek Parcel D1A Erosion Project (Project) consists of the placement of 9.3 cubic yards of rip rap to an impacted area along the bank. The rip rap will be placed by hand or by excavator from the top of the bank and secured with landscape fabric staples.

The Project will permanently impact 9.3 cubic yards of waters of the United States.

**PROJECT LOCATION:**

The Project is located at 2326 Dollarhide Road, Saint Helena, CA, 94574.

Latitude: 38.36328° and Longitude: -122.21511°

**PROJECT SCHEDULE:**

Construction for the Project is anticipated to begin in March 2025, and notification will be provided when the Project is complete.

**APPLICATION FEE RECEIVED:**

An application fee of \$4,212.00 was received on 27 February 2025.

The fee amount was determined as required by California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as category F- Emergency Projects authorized by a Water Board General Order (fee code 85) with the dredge and fill fee calculator.
