ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; HC REAL ESTATE HOLDINGS, INC., REGIONAL UNIVERSITY COMMUNITY BACKBONE INFRASTRUCTURE PROJECT (WDID#5A31CR00495A2), PLACER COUNTY

This Order responds to the 16 January 2026 request for an amendment of the Regional University Community Backbone Infrastructure Project (Project) Section 401 Water Quality Certification (WDID#5A31CR00495). The original Water Quality Certification (Certification) was issued on 5 February 2020. The Certification was amended on 6 February 2025. The requested amendment is hereby approved.
