ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; USA PROPERTIES FUND, INC. UNIVERSITY AVENUE APARTMENTS PROJECT (WDID#5A31CR00620A1), PLACER COUNTY

This Order responds to the 10 December 2025 request for an amendment of the University Avenue Apartments Project (Project) Section 401 Water Quality Certification (WDID#5A31CR00620). The original Water Quality Certification (Certification) was issued on 1 December 2025. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

There is a typographical error in the original Certification. The regulatory measure identification (Reg. Measure ID) was listed as 522335. The correct Reg. Measure ID is 422335. The Certification has been amended to reflect the correct Reg. Measure ID as 422335.

Additionally, USA Properties Fund, Inc. requested an amendment to reflect the U.S. Army Corps of Engineers (USACE) approved compensatory mitigation requirement. The Certification is amended to reflect the correct mitigation requirements as approved by the USACE under section 404 of the Clean Water Act. The original Certification reflected the incorrect mitigation ratio to be purchased from the Antonio Mountain Ranch Mitigation Bank Placer County Aquatic Resource Watershed Service Area.

Page 20 of 22 of the Order has been amended as follows:

7. Total Required Compensatory Mitigation

- a.** The Permittee is required to provide compensatory mitigation for the authorized impact to 0.11 acre of vernal pool habitat by purchasing 0.11

aquatic resource credits in the Antonio Mountain Ranch Mitigation Bank Placer County Aquatic Resource Watershed Service Area.

- b.** The Permittee is required to provide compensatory mitigation for the authorized impact to 0.13 acre of wetland habitat by purchasing 0.13 aquatic resource credits in the Antonio Mountain Ranch Mitigation Bank for the Placer County service area.
- c.** Total required Project compensatory mitigation information for permanent physical loss of area is summarized in Table 3. [Establishment (Est.), Re-establishment (Re-est.), Rehabilitation (Reh.), Enhancement (Enh.), Preservation (Pres.), Unknown].
