**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; CITY OF FOLSOM, FOLSOM
AREA SPECIFIC PLAN BACKBONE INFRASTRUCTURE PROJECT
(WDID#5A34CR00519A1), SACRAMENTO COUNTY**

This Order responds to the 3 April 2024 request for an amendment of the Folsom Area Specific Plan Backbone Infrastructure Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00519). The original Water Quality Certification (Certification) was issued on 18 October 2013 and a time extension was issued on 19 September 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The City of Folsom is requesting a time extension through 30 May 2029. A time extension was authorized by the United States Army Corps of Engineers on 30 May 2024. The City of Folsom has provided documentation from the United States Army Corps of Engineers (SPK-2007-02159) authorizing in-water construction activities to continue until 30 May 2029.

The Certification is amended to authorize in-water construction activities to continue until 30 May 2029.
