### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; LENNAR COMMUNITIES, SUN CREEK SPECIFIC PLAN, SIERRA SUNRISE PROJECT (WDID#5A34CR00620A2), SACRAMENTO COUNTY**

This Order responds to the 6 August 2024 request for an amendment of the Sun Creek Specific Plan, Sierra Sunrise Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00620A2). The original Water Quality Certification (Certification) was issued on 15 January 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

#### **AMENDMENT:**

Lennar Communities is requesting a time extension through 30 September 2029. The time extension will allow Lennar Communities to proceed with the Project described in the original Certification. The Central Valley Regional Water Quality Control Board received confirmation on 25 September 2024 from the United States Army Corps of Engineers (SPK-2005-00888) that in-water construction activities will be authorized to continue until 30 September 2029.

The Certification is amended to extend the expiration date until 30 September 2029.
