### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; FOOTHILL HOLDINGS LLC, THE SMITH PROPERTY PROJECT (WDID#5A34CR00621A1), SACRAMENTO COUNTY**

This Order responds to the 17 July 2024 request for an amendment of the Smith Property Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00621). The original Water Quality Certification (Certification) was issued on 15 March 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

#### **AMENDMENT:**

Foothill Holdings LLC is requesting a name change and time extension through 24 September 2029. The name change will allow Foothill Holdings LLC to proceed with the Project described in the original Certification.

The Central Valley Regional Water Quality Control Board received confirmation from the United States Army Corps of Engineers (SPK-2008-00795) that in-water construction activities will be authorized to continue until 24 September 2029.

The Certification is amended to show Foothill Holdings LLC as the permittee, and to authorize in-water construction activities to continue until 24 September 2029.
