ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; GRANITE CONSTRUCTION COMPANY, VINEYARD SOUTH MINE PROJECT (WDID#5A34CR00725A1), SACRAMENTO COUNTY

This Order responds to the 4 April 2025 request for an amendment of the Vineyard South Mine Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00752). The original Water Quality Certification (Certification) was issued on 3 April 2020. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Granite Construction Company is requesting a time extension through 3 April 2030 to be consistent with the expiration of the Letter of Permission authorized by the United States Army Corps of Engineers on 6 April 2020. Granite Construction Company has provided documentation from the United States Army Corps of Engineers (SPK-2018-00773) authorizing in-water construction activities to continue until 3 April 2030. The Certification is amended to revise the expiration date to 3 April 2030.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$130,000.00 for the original Certification were received on 7 September 2018. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
