ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; JEN CALIFORNIA 27 LLC, DELTA SHORES OFFSITE FORCE MAIN PROJECT (WDID#5A34CR00875A1), SACRAMENTO COUNTY

This Order responds to the 9 December 2024 request for an amendment of the Delta Shores Offsite Force Main Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00875).
