#### NOTICE OF APPLICABILITY; SECTION 401 GENERAL WATER QUALITY CERTIFICATION FOR REGIONAL GENERAL PERMIT 40 (ORDER NO. WQ 2023-0022-DWQ) FOR THE VACA-LAMBIE WATERCOURSE CROSSING IMPROVEMENTS PROJECT (WDID# 5A48CR00209), PACIFIC GAS AND ELECTRIC COMPANY BAY AREA OPERATIONS AND MAINTENANCE PROGRAM, SOLANO COUNTY

On 23 April 2025, Craig Geldard (Applicant) filed a notification requesting coverage under the Water Quality Order NO. WQ 2023-0022-DWQ] Waste Discharge Requirements and Clean Water Act Section 401 Water Quality Certification for the Vaca-Lambie Watercourse Crossing Improvements Project (Project). After reviewing the notification and the supplemental material submitted by the Applicant, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) has determined that the Project qualifies for enrollment under this General Certification Order. The proposed activity will take place within less than 0.0164 acre/63 linear feet of waters of the United States.

The Central Valley Water Board is certifying this Project under the General Certification. This Notice of Applicability (NOA) requires that the Project be implemented in conformance with the Project description in the Application and in compliance with the conditions of approval specified in this NOA and in the General Certification.

The Project is described in the notification form requesting coverage under the General Certification Order, dated 4 April 2023, and supplementary information (Application Package). Coverage under the General Certification Order is no longer valid if the Project (as described) is modified.

## **PROJECT DESCRIPTION:**

The 2.13-acre Vaca-Lambie Watercourse Crossing Improvements Project (Project) consists of road maintenance activities on approximately 2.5 miles of access roads serving the Vaca-Lambie 230kv line in Solano County. This work includes road surface blading to restore rolling dips and ensure proper stormwater drainage off the road surface at four locations. Crews will add rock to various locations within the road prism. At Crossing 1 an existing failed culvert will be removed and replaced with rock. At Crossing 2 an existing failed culvert will be removed and backfilled with soil and capped with rock. At Crossing 3, two 36-inch metal rusted culverts will be removed and replaced with dual 36-inch diameter high density polyethylene (HDPE) culverts. At Crossing 4, the existing dual 24-inch HDPE culverts will be removed and replaced.

The Project will temporarily impact 0.0004 acre/7.93 linear feet and permanently impact 0.016 acre/55.07 linear feet of waters of the United States.
