### **ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; TEHAMA COUNTY BOAT RAMPS CLEAN WATER ACT COMPLIANCE PROJECT – RIVER PARK SITE (WDID NO. 5A52CR00194A1), TEHAMA COUNTY**

This Order responds to the 1 November 2024 request for an amendment to the Tehama County Boat Ramps Clean Water Act Compliance Project – River Park Site Section 401 Water Quality Certification (WDID No. 5A52CR00194). The original Water Quality Certification was issued on 3 September 2019. The requested amendment is hereby approved, and the original Certification is therefore amended as described below. Tehama County is requesting an amendment to the Section 401 Water Quality Certification and Order to extend the original expiration date of 3 September 2024 to align with the United States Army Corps of Engineers' Letter of Permission (SPK-2018-00431) expiration date of 18 December 2029. The request has been approved and the expiration date of the Section 401 Water Quality Certification is **extended to 18 December 2029**.
