**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; COUNTY OF YOLO
DEPARTMENT OF COMMUNITY SERVICES, COUNTY ROAD 49 OVER HAMILTON
CREEK BRIDGE REPLACEMENT PROJECT (BRIDGE NO. 22C0095) (WDID#
5A57CR00211A1), YOLO COUNTY**

This Order responds to the 9 June 2026 request for an amendment of the County Road 49 over Hamilton Creek Bridge Replacement Project (Bridge No. 22C0095) (Project) Section 401 Water Quality Certification (WDID# 5A57CR00211). The original Water Quality Certification (Certification) was issued on 27 September 2023. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The County of Yolo Department of Community Services is requesting a time extension through 1 November 2028. A time extension was authorized by the United States Army Corps of Engineers on 10 June 2026. The County of Yolo Department of Community Services provided documentation from the United States Army Corps of Engineers (SPK-2023-00501) authorizing in-water construction activities to continue until 15 March 2031.

The Certification is amended to expire on 15 March 2031.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$2,734.00 for the original Certification were received on 14 August 2023. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
