**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; CALIFORNIA DEPARTMENT
OF WATER RESOURCES, DEPARTMENT OF WATER RESOURCES DEFERRED
MAINTENANCE SITE 545 (UNIT 2: LM 4.29) AND SITE 549 (UNIT 2: LM 5.40)
PROJECT (WDID#5A57CR00214A1), YOLO COUNTY**

This Order responds to the 2 February 2024 request for an amendment of the Department of Water Resources Deferred Maintenance Site 545 (Unit 2: LM 4.29) and Site 549 (Unit 2: LM 5.40) Project (Project) Section 401 Water Quality Certification (WDID#5A57CR00214). The original Water Quality Certification (Certification) was issued on 10 January 2024. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The California Department of Water Resources is requesting to change the United States Army Corps of Engineer Nationwide Permit (NWP) classification from NWP 33 to NWP 7 to be consistent with the United States Army Corps of Engineers authorization under Section 404 of the Clean Water Act.

The Certification is amended to reflect the USACE authorization for coverage under NWP 7 (SPK-2023-00751).

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$2,985.00 for the original Certification were received on 17 November 2023. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category E - Low Impact Discharges (fee code 87) with the dredge and fill fee calculator.
