ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; CALIFORNIA DEPARTMENT OF WATER RESOURCES, DEPARTMENT OF WATER RESOURCES DEFERRED MAINTENANCE SITE 545 (UNIT 2: LM 4.29) AND SITE 549 (UNIT 2: LM 5.40) PROJECT (WDID#5A57CR00214A2), YOLO COUNTY

This Order responds to the 11 September 2024 request for an amendment of the Department of Water Resources Deferred Maintenance Site 545 (Unit 2: LM 4.29) and Site 549 (Unit 2: LM 5.40) Project (Project) Section 401 Water Quality Certification (WDID#5A57CR00214). The original Water Quality Certification (Certification) was issued on 10 January 2024 and an amendment was issued on 29 February 2024. The requested second amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The California Department of Water Resources is requesting to update the United States Army Corps of Engineer Nationwide Permit (NWP) classification to include both NWP 7 and NWP 33 to be consistent with the United States Army Corps of Engineers authorization under Section 404 of the Clean Water Act. The original Certification classified the Project under NWP 33 but was later amended to NWP 7.
