**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY  
CONDITIONED WATER QUALITY CERTIFICATION; GREENLAW DEVELOPMENT  
LLC, MARIPOSA INDUSTRIAL PARK – PHASE 2 PROJECT (WDID#  
5B39CR00395A1), SAN JOAQUIN COUNTY**

This Order responds to the 30 May 2024 request for an amendment of the Mariposa Industrial Park – Phase 2 Project (Project) Section 401 Water Quality Certification (WDID# 5B39CR00395). The original Water Quality Certification (Certification) was issued on 3 April 2024. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

**AMENDMENT:**

Greenlaw Development LLC is requesting a project description update for their existing Certification. A 16-inch diameter pressurized water line will be installed under North Littlejohns Creek in the same location of the existing farm road crossing near the west edge of the site. An existing dirt farm road crossing that consists of pair of 30-inch diameter culverts and fill dirt in the channel will be removed to increase channel capacity from the encroachment restriction of flow.

Waterline installation includes removing the old farm road crossing and excavating a trench to a maximum depth of approximately 15 feet. Excavated soil will be stockpiled adjacent to the channel and excess soil will be disposed of in the uplands area outside the riparian corridor.

The Certification is amended to reflect the updated Project description and Table 1 of the Order as shown below:
