NOTICE OF APPLICABILITY; GENERAL SECTION 401 WATER QUALITY CERTIFICATION ORDER REQUIREMENTS FOR THE RECLAMATION DISTRICT 2040, RD 2040 VICTORIA ISLAND 2024 EMERGENCY LEVEE REPAIR PROJECT (WDID#5B39CR00418), SAN JOAQUIN COUNTY

On 20 June 2025, Reclamation District 2040 received a Notice of Applicability through the Clean Water Act Section 401 General Water Quality Certification of the United States Army Corps of Engineers (USACE) Regional General Permit 8 (WQ 2023-0061-DWQ) (General Certification Order). Following issuance of the NOA, the Applicant was notified that the Project would be authorized under a Nationwide Permit #3 (Maintenance Activities) through Section 404 of the Clean Water Act. This order rescinds the NOA issued on 20 June 2025 to a Water Act Section 401 General Water Quality Certification and Order of the United States Army Corps of Engineers 2021 Nationwide Permits (General Certification Order).

On 8 July 2025, the Applicant filed a request for coverage under the 25 February 2022 State Water Resources Control Board Clean Water Act Section 401 General Water Quality Certification and Order of the United States Army Corps of Engineers 2021 Nationwide Permits (General Certification Order) for the RD 2040 Victoria Island 2024 Emergency Levee Repair Project (Project). After review of the notification and the supplemental material submitted by the Applicant, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) has determined that the Project qualifies for enrollment under this General Certification Order. The proposed activity will take place within less than 0.6 acre/350 linear feet of waters of the United States.

The Central Valley Water Board is certifying this Project under United States Army Corps of Engineers Nationwide Permit #3 (Maintenance Activities), subject to the conditions and the notification requirements described in the Nationwide Permit ("Special Conditions"). This Notice of Applicability is being issued under the General Certification Order pursuant to Section 3838 of the California Code of Regulations.

The Project must proceed in accordance with the requirements contained in this Notice of Applicability and General Certification Order. The Project is described in the notification form requesting coverage under the General Certification Order, dated 15 March 2021, and supplementary information (Application Package). Coverage under the General Certification Order is no longer valid if the Project (as described) is modified.

#### PROJECT DESCRIPTION:

The 1.7-acre Reclamation District (RD) 2040 Victoria Island 2024 Emergency Levee Repair Project (Project) consists of placement of restoring the levee prism and integrity of the RD 2024 Victoria Island levee due to an imminent levee failure. 350 linear feet of fine-grained fill material and riprap on the waterside slope above and below the medium high watermark. The work occurred over multiple tidal cycles. The levee slope where the emergency fill and riprap was placed had preexisting riprap prior to the levee failure.

The Project will permanently impact 0.6 acre/350 linear feet of waters of the United States.
