ORDER AMENDING NOTICE OF APPLICABILITY, TECHNICALLY CONDITIONED GENERAL SECTION 401 WATER QUALITY CERTIFICATION ORDER REQUIREMENTS FOR PACIFIC GAS & ELECTRIC COMPANY, SAWMILL FLAT CULVERT IMPROVEMENT PROJECT, (WDID# 5C10CR00095A1), FRESNO COUNTY

This order responds to the 20 November 2025 request for an amendment of the Pacific Gas and Electric's Sawmill Flat Culvert Improvement (Project) Notice of Applicability (WDID No. 5C10CR00095). The original Notice of Applicability was issued on 27 November 2024. Pacific Gas and Electric is requesting a time extension through 1 November 2026 due to work suspension related to a fire evacuation order, caused by the Garnet Fire, and ongoing safety risks from 25 August 2025 to 7 October 2025.

AMENDMENT:

The Notice of Applicability is amended to change the Project completion date from 15 October 2025 to 1 November 2026. The time extension will allow Pacific Gas and Electric to proceed with the Project described in the original Notice of Applicability.
