### **NOTICE OF TERMINATION; GENERAL WASTE DISCHARGE REQUIREMENTS ORDER R5-2022-0006 FOR LIMITED THREAT DISCHARGES TO SURFACE WATER, AMPINE: A DIVISION OF TIMBER PRODUCTS COMPANY PROJECT, AMADOR COUNTY**

Thank you for submitting the Notice of Termination Form dated 11 October 2024 requesting termination of coverage under the Limited Threat General Order R5-2022-0006 for the Ampine: A Division of Timber Products Company (Project).

On 30 January 2018 the Central Valley Regional Water Quality Control Board issued a Notice of Applicability (NOA) for the Project, which was assigned Limited Threat General Order R5-2016-0076-018 and Waste Discharger Identification 5B03NP00009. On 17 February 2022, the Central Valley Water Board adopted Limited Threat General Order R5-2022-0006 (NPDES CAG995002), replacing Limited Threat General Order R5-2016-0076. Except for purposes of enforcement, NOA R5-2016-0076-018 is hereby terminated as of 11 October 2024 through this letter.

Please note that you must still submit your last quarterly monitoring report required under the Limited Threat General Order to the Compliance/Enforcement staff. Failure to do so subjects you to mandatory minimum penalties or discretionary penalties.
