ORDER R5-2015-0118

**RESCINDING WASTE DISCHARGE REQUIREMENTS/NPDES PERMITS**

The California Regional Water Quality Control Board, Central Valley Region, finds that the following Board adopted Orders and Resolutions are no longer applicable for the reasons shown:

**a. Anderson**

Waste Discharge Requirements (WDRs) Order 87-110, adopted on 26 June 1987, and prescribes requirements for the discharge from Anderson-Cottonwood Irrigation District (ACID), Shasta and Tehama Counties (Facility). The Facility comprises the entirety of their irrigation water distribution canal system. The Facility was issued WDRs due to their application of pesticides, algacides, and herbicides. The facility has been enrolled in the State Water Board's General Order 2013-0002-DWQ. Therefore, it is appropriate to rescind WDRs Order 87-110.

**b. Aramark**

Waste Discharge Requirements Order 99-028, adopted on 30 April 1999, prescribes requirements to Aramark Uniform Services, Inc., and Kirshbaum Family Holdings Company for the discharge of treated groundwater from a groundwater remediation treatment system. The groundwater treatment systems at both the on- and off-site treatment locations have been shut down because groundwater cleanup efforts have been successful. In addition, groundwater monitoring wells and re-infiltration wells associated with each treatment system have been destroyed in compliance with State and local guidelines. Therefore, it is appropriate to rescind WDRs Order 99-028

**c. Sound Stud Sawmill**

Waste Discharge Requirements Order R5-2003-0139, adopted on 5 September 2003, prescribes requirements for wastewater discharges from Sound Stud Sawmill (Facility). The Facility is comprised of a combined wastewater/storm water collection system with discharge to an unlined recycle pond. The facility is no longer in operation. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2003-0139.

**d. United Parcel Service**

Waste Discharge Requirements (WDRs) Order 00-262, adopted on 8 December 2000, prescribes requirements for the discharge from United Parcel Service, Anderson facility, Shasta County (Facility). The Facility is comprised of a wastewater collection system with a septic tank and leachfield. The Facility was issued WDRs due to an Underground Storage Tank (UST) cleanup case at the site, which could have allowed contaminants to enter groundwater through the facility's leachfield. The cleanup activities have been completed and the Regional Boards UST case for the site has been closed. Therefore, it is appropriate to rescind WDRs Order 00-262.

IT IS HEREBY ORDERED that the above orders are rescinded.
