The request must explain the basis for

status as a designated party and in particular how the person is directly affected by the discharge.

The Tentative Permit was issued for a 30-day public comment period on **1 October 2020** and comments are due by **5:00 p.m.** on **2 November 2020**. Written evidence or comments submitted after **5:00 p.m.** on **2 November 2020** will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any person requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
