***RESPONSE TO COMMENTS; TENTATIVE WASTE DISCHARGE REQUIREMENTS;
COUNTY OF LAKE PUBLIC SERVICES DEPARTMENT; EASTLAKE SANITARY
LANDFILL; LAKE COUNTY***

At a public hearing scheduled for 20/21 June 2024, the Regional Water Quality Control Board, Central Valley Region, (Central Valley Water Board) will consider adoption of revised Waste Discharge Requirements (WDRs) and revised Monitoring and Reporting Program (MRP) for the County of Lake Public Services Department's (Discharger) Eastlake Sanitary Landfill (Facility) in Lake County.

This document contains responses to written comments received in response to the public notice circulated on 1 February 2024 from interested persons regarding the tentative WDRs and MRP. To receive full consideration written comments to the public notice were required to be received by the Central Valley Water Board by 4 March 2024.

Comments received were from (1) the Discharger, (2) the Koi Nation of Northern California (Koi Nation), and (3) the Yocha Dehe Wintun Nation.

The comments received are summarized in the enclosure, followed by responses from Central Valley Water Board staff and details of any changes made to the tentative WDRS and MRP in response to the comments received. In addition, staff has made minor changes to the tentative WDRs and to improve clarity and fix typographical errors.

The comments and our response to comments will be uploaded to our web page within the next few days. Based on the comments received, the tentative WDRs and MRP with the appropriate changes noted has been added to the agenda for the 20/21 June 2024 Board Meeting in Rancho Cordova, California on the uncontested calendar.
