**REVISED NOTICE OF PUBLIC HEARING**

TENTATIVE ORDER

WASTE DISCHARGE REQUIREMENTS ORDER R5 2024-####  
GREENLAW DEVELOPMENT LLC  
MARIPOSA INDUSTRIAL PARK – PHASE 3 PROJECT  
SAN JOAQUIN COUNTY

A tentative Waste Discharge Requirements Order (Order) is proposed for the Greenlaw Development LLC (Permittee), Mariposa Industrial Park – Phase 3 Project (Project) in San Joaquin County. The 206-acre Project is the third phase of a new industrial park with several large buildings and access from Mariposa Road. The project will tie-in to the existing City of Stockton (city) storm drain system. Phase 3 work is needed to complete construction of an access road to the city detention basin and a truck trailer parking lot. Phase 3 construction will fill 0.34 acre of isolated wetlands with approximately 275 cubic yards of clean fill dirt. Phase 3 construction is planned to commence in Fall 2024. The work will be accomplished when the seasonal wetlands are dry.

The tentative Order provides details of the proposed Project activities, including compensatory mitigation measures planned to compensate for the permanent loss of waters of the state and requiring avoidance and minimization measures to reduce on-site impacts during construction activities. The tentative Order describes technical conditions required to be met throughout the implementation of construction activities that allow for activities to meet Basin Plan objectives.

Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board **no later than 5 p.m on 23 August 2024**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board via email to [Sara.Gevorgyan@Waterboards.ca.gov](mailto:Sara.Gevorgyan@Waterboards.ca.gov) **no later than 5 p.m on 23 August 2024**. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
