RESOLUTION R5-2024-XXXX

ADOPTING THE 2024 TRIENNIAL REVIEW AND WORKPLAN FOR THE SACRAMENTO AND SAN JOAQUIN RIVERS BASINS AND THE TULARE LAKE BASIN

WHEREAS, the California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds the following:

- 1. In 1975 the Central Valley Water Board adopted the Water Quality Control Plan for the Sacramento and San Joaquin Rivers Basins and the Tulare Lake Basin (Basin Plans), which has been amended occasionally.
- 2. The Basin Plans contain the beneficial uses, water quality objectives, and implementation programs for the Sacramento and San Joaquin Rivers Basins and the Tulare Lake Basin.
- 3. Section 303(c)(1) of the Clean Water Act (CWA) requires that water quality standards be reviewed at least every three years and section 13240 of the Water Code requires periodic review. This review is known as a Triennial Review.
- 4. In accordance with State Water Resources Control Board (State Water Board) procedures for conducting a Triennial Review, Central Valley Water Board staff circulated a list of water quality issues to receive public comment regarding the list and other potential issues.
- 5. Central Valley Water Board staff developed a Workplan using the prioritization criteria that was approved during the 2018 Triennial Review and considered comments by the public to rank and address the proposed projects.
- 6. The Workplan includes a review of Basin Plan Amendments since the 2021 Triennial Review, an overview of the proposed projects, and project prioritization and ranking.
- 7. The Workplan has been circulated to the public, including Tribes, public agencies, environmental justice groups, and interested individuals for review and additional comment.
- 8. Central Valley Water Board staff have responded to all additional written comments and revised the Workplan, as appropriate.

9. The Central Valley Water Board held a public hearing on 13 December 2024 in Rancho Cordova, California to receive public comment on the ranking of the projects and the proposed Workplan. Notice of the public hearing was sent to all interested persons consistent with state and federal requirements.

THEREFORE, BE IT RESOLVED:

- 1. The Central Valley Water Board hereby adopts the Triennial Review Workplan and Addendum in accordance with the requirements of section 303(c)(1) of the Clean Water Act and Water Code section 13240.
- The Central Valley Water Board reaffirms its intent to address the priority projects identified during the Triennial Review process as described in the Workplan, to the extent resources allow.
- The areas of the Basin Plan not identified as needing investigation and possible revisions are hereby affirmed as adequate; however, this determination does not preclude the consideration of other issues for possible revision or amendment of the Basin Plans.
- 4. The entire Basin Plan shall remain in effect until such time that appropriate and specific amendments on priority issues are adopted by the Central Valley Water Board and approved by the appropriate review authorities.
