The date, time, and location of the public meeting may change after this Notice is issued. A Final Agenda for the meeting will be made available at least 10 days before the meeting. The Final Agenda will provide the location and format of the meeting, the anticipated date that the proposed order will be considered, and the anticipated order of all agenda items; however, the Board may consider agenda items out of their listed order. The agenda materials may also include staff revisions to the proposed order.

Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water Board no later than **5:00 p.m. on 3 March 2026**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

If adopted, Waste Discharge Requirements (WDRs) Order R5-2026-XXXX will prescribe requirements for management of waste discharged to the closed Sierra Conservation Center Landfill, located at 5100 O'Brynes Ferry Road, Jamestown, CA 95327. Sierra Conservation Center Landfill (Facility) is owned and operated by California Department of Corrections and Rehabilitation (Discharger). The Discharger will be responsible for

maintaining compliance with Order requirements. The Facility is located on and associated with the Sierra Conservation Center prison complex. The 0.7-acre Facility closed in 1995. The Facility's waste discharges are currently regulated under WDRs Order 96-010. If adopted, the proposed WDRs Order R5-2026-XXXX will rescind and replace the previous WDRs Order 96-010 and will result in updates regarding the Facility, including the closure of the Facility and installation of additional monitoring wells.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order was sent only to the Discharger.
