Tentative Time Schedule Order Information

The City of Lodi (Discharger) owns and operates the White Slough Water Pollution Control Facility (Facility), located at 12751 North Thornton Road, Lodi, CA 95242. The Facility is a publicly-owned treatment works and provides sewerage service for the City of Lodi and the San Joaquin County Flag City Service Area with a total population of approximately 67,000. The Facility is permitted to discharge 8.5 MGD of tertiary treated wastewater to Dredger Cut within the Sacramento-San Joaquin Delta. The Central Valley Water Board and United States Environmental Protection Agency classify the Facility as a major facility.

Discharges from the Facility are currently regulated by Notice of Applicability (NOA) R5-2023-0025-XXX, issued by the Executive Officer of the Central Valley Regional Water Quality Control Board (Central Valley Water Board) and effective 1 April 2025, authorizing coverage under the Municipal Wastewater Dischargers That Meet Objectives/Criteria at the Point of Discharge to Surface Water Order R5-2023-0025 (Municipal General Order). A Time Schedule Order (Order) is proposed to allow the Discharger time to comply with the final effluent limitations for ammonia contained in the NOA. The Discharger has submitted an infeasibility report detailing proposed compliance projects and control measures, including a proposed time schedule for compliance with the final effluent limitations for ammonia. Therefore, an Executive Officer-issued Time Schedule Order is proposed containing a time schedule for compliance with these final effluent limitations until 1 January 2028.

Comment Period

Persons wishing to comment in writing on the proposed Time Schedule Order must submit such comments no later than 5:00 p.m. on **12 March 2025** to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov. The Board may refuse to admit untimely written materials and shall refuse to do so when there is a

showing of prejudice to the Discharger or the Board. Excluded material will not be considered.
